- Rebates are subject to change without notice and are subject to approval.
- To be eligible for City of Tallahassee Utilities (City) rebates, ENERGY STAR (ES) qualifying residential units must utilize natural gas for water heating. If natural gas is unavailable, and gas main extension to the site is denied by the City's Gas Utility, units must utilize an ES qualified electric water heater with Energy Factor (EF) 2.0 or greater; or ES qualified solar water heating.
- For incentives to be paid, this application must be completed entirely and submitted with required documentation (see above).
- Individual HERS ratings of individual units must be conducted by a Florida State-Certified HERS Level 1 Rater.
- HERS Rater inspection/testing/rating/verification of each unit is required.
- Use this Application form for homes with Permit Request Date after 7/1/12, and/or Final Inspection after 1/1/13.
- Applications must be received within 90 days of the unit's Final Inspection date.
- Homebuilders can apply for ES \$1/s.f. incentives as well as gas appliance rebates; but may not apply for both ES \$1/s.f. rebates as well as City ES rebates for individual electric appliances.
