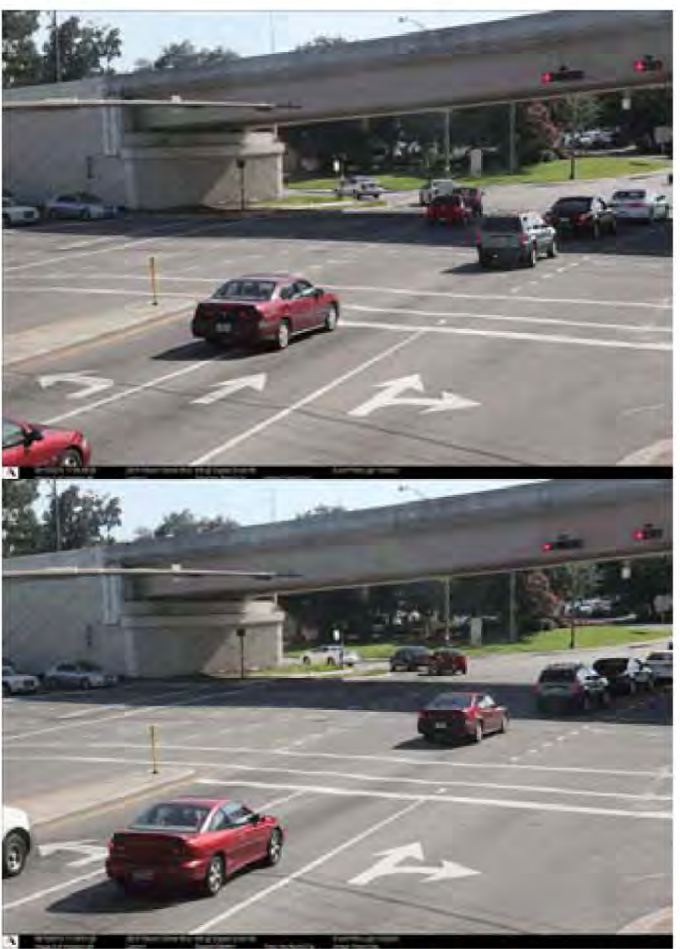

**THIS IS A NOTICE OF VIOLATION**

On the date and time listed below, your motor vehicle was photographed in the listed intersection while the traffic control signal was red. Pursuant to Section 316.0083, (b) 1.a, Florida Statutes, the owner of a motor vehicle is liable for payment of \$158.00, if the owner's vehicle proceeds into an intersection equipped with a Traffic Infraction Detector when the traffic control signal for that motor vehicle's direction of travel is emitting a steady red signal and the motor vehicle did not come to a complete stop before proceeding into the intersection.

**FAILURE TO PAY THE VIOLATION PENALTY WITHIN 30 DAYS OF THE DATE LISTED ON THIS NOTICE OF VIOLATION (DUE DATE) WILL RESULT IN A UNIFORM TRAFFIC CITATION ISSUED TO THE REGISTERD OWNER OF THE VEHICLE. THE FINE WILL THEN INCREASE TO \$271.00 MINIMUM. FAILURE TO PAY THE UNIFORM TRAFFIC CITATION MAY RESULT IN ADDITIONAL COURT COSTS, FEES AND POSSIBLE LOSS OF DRIVING PRIVILEGES.**
