Affordable Housing Advisory Committee

Membership Criteria

Purpose/Function

The Committee shall be comprised of eleven (11) members appointed by the City Commission by resolution. Committee members will be selected based on their qualifications and willingness to serve. Members will be selected without regard to race, creed, national origin, age, sex or the presence of a disability. As much as possible, the Committee will be made up of an equitable representation of City residents based on race and sex according to the demographic ratio of the City. In consideration of the Americans with Disabilities Act, efforts should be made to include members with disabilities.

This Committee shall serve in an advisory capacity to the Tallahassee City Commission and to the Department of Economic and Community Development on issues presented to the Committee related to affordable housing and to perform functions as provided in Ordinance 08-O-24, as codified in the City of Tallahassee Code of General Ordinances and amended from time to time, and Chapter 420, Florida Statutes and herein (hereinafter referred to as the Regulations).

1. The members of the Committee shall include:
 - a. One (1) citizen who is actively engaged in the residential home building industry in connection with affordable housing.
 - b. One (1) citizen who is actively engaged in the banking or mortgage banking industry in connection with affordable housing.
 - c. One (1) citizen who is a representative of those areas of labor actively engaged in home building in connection with affordable housing.
 - d. One (1) citizen who is actively engaged as an advocate for low income persons in connection with affordable housing.
 - e. One (1) citizen who is actively engaged as a for-profit provider of affordable housing.
 - f. One (1) citizen who is actively engaged as a not-for-profit provider of affordable housing.
 - g. One (1) citizen who is actively engaged as a real estate professional in connection with affordable housing.
 - h. One (1) citizen who is actively serves on the Tallahassee-Leon County Planning Commission.
 - i. One (1) citizen who represents its employers within the jurisdiction of the City of Tallahassee.
 - j. One (1) citizen who represents essential services personnel, as defined in the City of Tallahassee Local Housing Assistance Plan.
 - k. One (1) citizen at large.

2. If due to some reasonable factor, such as the presence of a conflict of interest by the prospective appointees, the City is unable to appoint a citizen actively engaged in the referenced activities in connection with affordable housing, a citizen engaged in the activity without regard to affordable housing may be appointed.

Airport Advisory Committee

Membership Criteria

All members shall reside within the Tallahassee Regional Airport Market Service Area. None shall have a direct financial interest in or be employed by any entity that does business at Tallahassee Regional Airport. At least one member shall reside or do business outside Leon County.

Members shall be respected business and professional people, holding or having held a number one or number two leadership position in their respective organizations, who are regular airport customers. Consideration will be given to appointing members who have specific expertise in economic development, banking, design, marketing, pilot credentials, general aviation, neighborhood association representation, accounting, business and commercial law, retail sales, property management, and business development. Two of the committee seats shall be automatically and permanently filled by the Presidents of the Greater Tallahassee Chamber of Commerce and the Executive Director of Visit Tallahassee.

Architectural Review Board

Membership Criteria

All members of the ARB shall be residents or property owners in the City of Tallahassee and/or Leon County. The members of the ARB shall be selected from the following classifications: a) Four members who are owners of property zoned Historic Preservation Overlay (HPO) (two appointed by City, two appointed by County); b) Two members who are members of the American Institute of Architects and whose principal place of business or residence is Leon County (one appointed by the City, one appointed by the County); c) Two members from the Tallahassee Trust for Historic Preservation (one appointed by the City, one appointed by the County); d) the Chairperson of the Tallahassee-Leon County Planning Commission; and e) the Director of the Tallahassee-Leon County Planning Department.

Purpose/Function

The purpose of the ARB is to preserve the distinctive character of the historical areas and other specific structures and landmarks identified by the City or County Commissions. To accomplish this purpose, the ARB shall approve, disapprove, or require modification to plans for buildings to be erected, constructed, altered, renovated, moved or razed, as they apply to the Historic Preservation Overlay Zoning District as described in Section 10-319(a)(2), Tallahassee Land Development Code. It may also assist the Planning Commission in determining areas suitable for the location into the Overlay Zoning District.

Construction Industry BOARD ABOLISHED ORDINANCE 11-O-08 Four (4) members shall be registered or certified under F.S. Chapter 489, Part I or Part II, (1) from each of the following areas of expertise: natural gas, plumbing, electrical, and mechanical. Two (2) journeymen (either electrical, plumbing, or natural gas) shall be certified by the City. And three (3) members shall be citizens at large, and shall be City residents that are not, and have never been, members or practitioners of a profession regulated by the Construction Industry Review Committee or a member of any closely related profession.

Purpose/Function

To serve in an advisory capacity to the Tallahassee City Commission and to the Growth Management Department on issues presented to the Committee related to the construction industry licensing and to perform functions as provided in Ordinance 94-0-0020AA, as codified in the City Land Development Code and amended from time to time, and Chapter 489, Florida Statutes and herein (hereinafter referred to as the Regulations).

1. Receive, review and approve or disapprove applications from persons requesting to be examined for plumbing, electrical and natural gas journeyman competency certification.
2. Select a private business to prepare examinations, examine applicants, proctor examinations, grade examinations and provide grade results to the Committee.
3. Perform all building industry disciplinary activities as required by the Regulations.
4. To hear testimony relative to alleged violations of City codes under its jurisdiction.
5. To issue findings of facts, conclusions of law, and orders which shall have the force of law and set forth the steps necessary to accomplish bringing a violation into compliance with the technical code that has been violated.

Board of Adjustment and Appeals

Membership Criteria

There is hereby created the board of adjustment and appeals, which shall be composed of three members appointed by the county commission and three members appointed by the city commission, and a seventh member whose position shall alternately be appointed by the city and the county. The City and County Commission may appoint each an alternate member who shall serve at adjustment and appeal board meetings if their presence is needed to constitute a quorum. All appointees to the board of adjustment and appeals shall be residents of the county.

Purpose/Function

The board of adjustment and appeals shall have the following powers and duties under the zoning, housing, building, plumbing, gas, and fire prevention codes (regulatory codes) of the city and the county:

(1) Appeals of administrative decisions. To hear and decide appeals, as set forth in this Code. Whenever it is claimed that the true intent or meaning of any of the regulatory codes referred to in this section or any of the regulations contained therein or promulgated thereunder have been misconstrued or wrongly interpreted, the owner, or his duly authorized agent, may appeal from the decision of the administrative officer of the regulatory code involved to the board of adjustment and appeals. Notice of appeal shall be in writing and filed within 30 calendar days after the decision is rendered by the responsible administrative officer under the regulatory code.

(2) Variances. To hear and decide variances for single-family and duplex dwelling units. A variance is defined as a relaxation of the terms of the Code or regulation involved where such variance will not be contrary to the public interest and where, owing to conditions peculiar to the property and not the result of the actions of the applicant, a literal enforcement of the regulatory code involved would result in undue hardship. Establishment or expansion of a nonconforming use shall not be allowed by variance nor shall a variance be granted because of the presence of nonconformities in the zoning district or adjoining districts. No use variances are permitted.

(3) Additional powers. The board of adjustment and appeals shall perform such additional duties as may by ordinance be delegated to it, and which pertain to the above assigned powers.

1. All members of the COUNCIL shall be City or County residents, City or County property owners, or City utility customers, and shall be a qualified elector residing in the County.
2. No individual committed to, or owing allegiance to, any particular arts faction shall be eligible to serve on the COUNCIL.

Purpose/Function

The function of the COUNCIL shall be to (as per 265.32 FL Statutes):

1. Stimulate greater governmental and public awareness and appreciation of the importance of the arts to the people of Tallahassee/ Leon County.
2. Encourage and facilitate greater and more efficient use of governmental and private resources for the development and support of the arts.
3. Encourage and facilitate opportunities for Tallahassee/ Leon County residents to participate in artistic activities.
4. Promote the development of resident artists, arts institutions, community organizations sponsoring arts activities, and audiences.
5. Survey and assess the needs of the arts, artists, arts institutions, community organizations sponsoring arts activities, and people of Tallahassee/ Leon County relating to the arts.
6. Support and facilitate the preservation and growth of the state's artistic resources.
7. Contract for artistic services, performances and exhibits.
8. Develop a center or complex of physical facilities for the use of the arts.
9. Provide financial and/or technical assistance to artists, arts institutions, and audiences.
10. Otherwise serve the citizens of the City and County in the realm of the arts.

- e. Southside Business Association;
- f. Florida Agricultural and Mechanical University (Non-Voting); and
- g. Florida State University (Non-Voting)

The representatives from the Greater Front Porch Community and Southside Neighborhoods must be a current resident of the area they are representing. The representative for the Gaines Street Vitalization Committee must be a member of the Gaines Street Vitalization Committee. The representatives from the Capital City Chamber of Commerce and the Southside Business Association must either operate a business or own commercial/retail property within the Redevelopment Area. A committee member may only represent one organization or area.

Purpose/Function

The UDC's duties shall be those set forth in Section 2-237, Land Development Code, related to the review of applications for development within the Gaines Street Urban Infill and Redevelopment Area and certain other areas, which include the following:

1. Rendering a final decision on conformance with the design standards, architectural standards, streetscape standards, signage, lighting design and placement of fixtures for site plans, including site plans for special exception uses, applicable to properties in the design review districts;
2. Rendering an advisory decision to the developer on conformance of proposed site plans with development and design standards, architectural standards, streetscape standards, signage, lighting design, and placement of fixtures for site plans, including site plans for special exception uses within the Capitol Center Planning District; and for properties owned by the City.
3. Forwarding such decisions to the director of growth management, including an explanation of the applicable provisions of the Gaines Street Redevelopment Plan and its implementing zoning districts, and the FSU Transition Area.
4. Rendering a recommendation to the Development Review Committee (DRC) on deviations to development and design standards for all site plan features noted above applicable to properties in the design review districts, FSU Transition Area, Capitol Center Planning District, and other City-owned properties within the City.
5. Participating in the development of design regulations and reviewing proposed development regulations and amendments and making recommendations to the City Commission as requested; and.
6. Other tasks that may be assigned from time to time by the City Commission.
7. Notwithstanding anything in this section to the contrary, development or redevelopment on the block known as Kleman Plaza, which has its own design review board, shall be exempt from review by the Urban Design Commission.
