

### IV: ADDITIONAL TERMS AND CONDITIONS

- Term.** This membership is for an initial term of twelve (12) months beginning . After the initial (12) month term, memberships continue on a month to month basis.  (Initials)
- Transfer of Membership.** Memberships are not transferable.
- Additional Parties to the Agreement.** Members may add a spouse and legal dependents under eighteen (18) years of age by completing the Family Membership Information section of this agreement.
- Termination of Membership by Member.** If Member elects to terminate this agreement prior to the end of the term defined in the Terms of this contract, a cancellation fee of \$200 or the remaining monthly dues (whichever is less) shall be charged to the bank account on file with Hilaman. After the initial twelve (12) month term, memberships continue on a month to month basis and monthly dues will continue to be charged to bank account / charge card on record until such time as member submits, in writing, by the 15th of the month prior to the month of desired termination, notice of termination of membership. No refunds shall be made for prepaid memberships.
- Use of Facility.** All golfers are expected to abide by the rules of the golf course. Please keep carts on the cart paths around tees and greens and on all par 3s. All golfers are expected to follow any cart restrictions. Members must check in at the Pro Shop before each round of play.
- Waiver of Claim.** It is expressly agreed that all use of Hilaman and Jake Gaither facilities shall be undertaken by Member or guest at his/her sole risk, and, Hilaman and Jake Gaither shall not be liable for any injuries or any damage to any member or guest, or the property of any member or guest, or be subject to any claim, demand, injury or damages, whatsoever, including without limitation, those damages resulting from acts of active or passive negligence on the part of Hilaman and Jake Gaither.
