RESPONSE TO SCENE

On May 19, 2020 at 1:20a.m., the Consolidated Dispatch Agency received a call for service at the Circle K at 2683 North Monroe Street, regarding a subject who was bleeding. Officers DeGraw and responded and made contact with victim Richard Haines, who was bleeding from the area of his eyes, elbows, and knees. Haines reported the suspect, who was later identified as Wilbon Woodard, threatened him with a knife and battered him while they were across the street at the China Super Buffet (2698 North Monroe Street). Haines advised he likely lost his cell phone during the fight at the China Super Buffet and Woodard was possibly still at the incident location. Haines provided a description of Woodard. went to the China Super Buffet, attempting to locate Haines' cell phone. While searching for the phone, Woodard emerged from behind the building, concealing his right hand behind some nearby bushes. When directed Woodard to show his hands, Woodard revealed a knife in his right hand and began advancing toward . gave Woodard several commands to drop the knife, but Woodard refused and continued charging toward shot at Woodard, ultimately striking and killing him.

I was contacted to assist with investigating the shooting. Prior to my arrival, Officers DeGraw and had been separated. I was informed Officer DeGraw was not involved in the shooting, but he heard and observed parts of the shooting as he ran from the Circle K to the China Super Buffet. Officers DeGraw and were transported to the Criminal Investigations Bureau for follow-up.

had his handgun holstered with a magazine seated in the weapon and two magazines secured in pouches on the left side of his duty belt. Officer French counted the rounds of ammunition in handgun and magazines. was carrying a Glock 22 .40-caliber semi-automatic

handgun which contained one unfired cartridge in the chamber. There was a 15-round capacity magazine seated in the magazine well of the handgun, which contained eight unfired cartridges. In the magazine pouch closest to belt buckle was a 15-round capacity magazine which contained 15 unfired cartridges. In the magazine pouch farthest from belt buckle was a 15-round capacity magazine which contained 15 unfired cartridges was not in possession of any other firearms or ammunition.

It is standard for Officers to carry each of their three issued handgun magazines loaded to capacity (15) with one (1) cartridge chambered in their handguns, totaling 46 rounds (15+15+15+1) had was carrying 39 cartridges at the time of inspection, indicating likely fired seven (7) cartridges during the shooting the incident.

The collection of evidence occurred from approximately 3:15a.m. until 3:34a.m. on May 19, 2020. Officer French issued a temporary replacement handgun upon conclusion.

Forensic Scientist (F.S.) Vernon Henderson took digital photographs of the handgun, cartridges, and magazines as they were counted. F.S. Henderson impounded the handgun, cartridges, and magazines as evidence. F.S. Henderson took digital photographs of who was wearing a standard police uniform. advised he did not have any physical contact with Woodard, therefore there was no expectation Woodard's DNA would be present on or about . No buccal sample was collected from because there was no expectation that DNA would be present on or about Woodard.

body worn camera was obtained and Investigator Bailey initiated an upload of the video from the incident. However, was escorted to the Watch Commander's Office to have a download conducted for his Taser activity. Sergeant Ginny Osborn stood by with the body camera until the upload was completed. Sergeant Osborn verified the video properly uploaded before she returned body worn camera

While in the Watch Commander's Office, Sergeant Chris Papy conducted a download of Taser activity. The activity indicated Taser was not used during his encounter with Woodard. 2020-CA-1011 Sergeant Papy, and Investigator Bailey were present during the download of the Taser activity.

Tallahassee Police Department General Order 63 (Officer-Involved Action Resulting in Serious Injury or Death) mandates "Each involved officer shall initially be placed on administrative leave for a minimum of 72 hours, followed by an administrative assignment as directed by the Chief of Police or designee." In accordance with this policy, Chief Lawrence Revell met with and provided him notification he was being placed on administrative leave. was driven home by Officer Armstrong.

INTERVIEW WITH WITNESS OFFICER, ELIJAH DEGRW

On May 19, 2020 at approximately 4:00a.m., Officer DeGraw was interviewed in the Criminal Investigations Bureau Interview Room 1 regarding the shooting incident. The interview was audio and video recorded. Officer DeGraw was advised of oath and perjury via written warning, which he indicated verbally and via signature he understood. Officer DeGraw swore or affirmed the statement he would provide would be wholly true.

Officer DeGraw advised the following:

Officer DeGraw works the midnight shift (21:15-07:15) in the Northwest District of the City of Tallahassee. Officer DeGraw was finishing a call for service at a hotel on North Monroe Street when he observed the call for service at Circle K regarding Haines' injuries. Officer DeGraw requested Dispatch send him the call at Circle K and he arrived on scene shortly thereafter. Another Officer was en route to be Officer DeGraw's back-up, but cancelled the other unit and responded to assist Officer DeGraw. Haines was bleeding from the areas of his eyes, elbows, and knees, as though he'd been in a fight on the ground. Haines reported he had only recently met Woodard and thought his first name was possibly "Michael." Haines advised he was drinking and eating pizza with Woodard and several other transients across the street at the China Super Buffet. Haines recalled Woodard was carrying two knives and began threatening people with the knives. Haines told Woodard to stop threatening people with the knives. Woodard pulled out a knife and threatened to cut and kill Haines with the knife, at which time Haines and Woodard began physically fighting. Woodard did not use the knife to harm Haines, but Haines recalled Woodard using his hands to attempt to gouge out Haines' eyeballs. Haines said he was able to get away and come across the street to Circle K. Haines advised his cell phone possibly fell out during the fight at the China Super Buffet. Haines advised Woodard was possibly still at the incident location, as well. Haines described Woodard as a white male with a short, crew-style haircut wearing a shirt, long pants, and being in the company of a small, black dog, which was possibly a chihuahua. While Officer DeGraw was obtaining Haines' statement, arrived at Circle K and witnessed a portion of the interview. Officer DeGraw asked could go across the street to the China Super Buffet to check for Haines' phone. was provided a description of Woodard. drove across the street to the China Super Buffet and Leon County Emergency Medical Services assisted Haines to the ambulance. As Haines was being evaluated, Officer DeGraw observed standing near the drive-through awning of the China Super Buffet, illuminating Woodard near bushes at the northeast corner of the building with his flashlight. Officer DeGraw told LCEMS personnel he had to go across the street and Officer DeGraw began running toward the China Super Buffet. While crossing the street, Officer DeGraw heard yelling, "Drop the knife! Drop the knife! Drop the knife!" as Woodard advanced toward who was running from the area of the drive-through awning toward North Monroe Street. Officer DeGraw heard approximately 5-7 gunshots fired. Woodard continued

to advance toward _____, despite being shot, or at least shot at. Officer DeGraw notified Dispatch that shots had been fired. By the time Officer DeGraw reached the eastern parking lot of the China Super Buffet, _____ was holding Woodard at gunpoint and the black dog was still on scene. Woodard was in a prone position with his head toward North Monroe Street (east) and his feet toward the China Super Buffet building (west). Woodard's left hand was under his torso and his right hand was extended outward, above his head with a large fixed-blade knife, inches away from his right hand. There was at least one knife sheath on Woodard's hip, but there may have been two. Woodard had an apparent gunshot wound to his forehead. Woodard's injuries and condition were inconsistent with life (motionless and not making any noise). Although Officer DeGraw believed Woodard was deceased, he requested Dispatch send LCEMS to the scene for Woodard's injuries. Officer DeGraw put gloves on his hands and handcuffed Woodard while _____ continued to provide deadly cover. LCEMS came from across the street and several Officers arrived on scene to assist, including Sergeant Kathy Connell. Sergeant Connell informed LCEMS Woodard was deceased and requested they not manipulate the scene. Sergeant Connell assigned Officer Joshua Armstrong to accompany _____, and she assigned Officer Gary Senters to accompany Officer DeGraw. Officer DeGraw was not questioned about the incident by anyone prior to the interview.

Officer DeGraw's body worn camera was uploaded and a verification was conducted to confirm the video was properly uploaded. Officer DeGraw's verbal account of the incident was consistent with the footage captured via his body worn camera. During the interview, Officer DeGraw's recounted Haines provided a potential name for Woodard, which was possibly "Michael." Officer DeGraw stated he wasn't confident "Michael" was the name Haines provided for Woodard. DeGraw's body camera video captured Haines providing the name "William" as a possible first name for Wilbon Woodard.

INTERVIEW WITH WITNESS, LEON COUNTY EMERGENCY MEDICAL SERVICES LRNP JASON PEREZ

On Wednesday, May 20, 2020 at approximately 9:00a.m., Investigators conducted an interview with LRNP Jason Perez. At the time of the shooting incident, Perez was working for LCEMS. Perez and his partner responded to the Circle K for Haines' injuries. While on scene at Circle K, Haines made disclosures to Perez about the battery incident between Haines and Woodard. Additionally, Perez heard and observed portions of the shooting incident involving _____ Perez also responded to the China Super Buffet for Woodard's injuries. Please see Investigator Daniel Warren's supplemental report and body worn camera video for information regarding the interview.

users. The videos from [redacted] body worn camera were restricted to only users who required access for the purpose of the criminal investigation [redacted] was excluded from that list.

On Wednesday, May 20, 2020 at approximately 3:00p.m., [redacted] came to the Tallahassee Police Department to review body worn camera footage and provide a statement regarding the shooting incident. [redacted] was accompanied by his attorney, 2020-CA-1011 [redacted] and [redacted] were escorted to the Criminal Investigations Bureau conference room to review the videos.

The two videos from [redacted] body worn camera were queued up in separate screens. The first video was from [redacted] arrival at Circle K. The second video captured [redacted] interaction with Woodard at the China Super Buffet, as well as the shooting incident. [redacted] was directed to watch only the videos which were queued on the screens. [redacted] 2020-CA-1011

The directive and interactions with [redacted] were captured via body worn camera. A review of the audits confirmed [redacted] complied with that direction and did not access either of his videos outside of the designated opportunity to review them on May 20, 2020.

On 5/19/20, I responded as one of the on-call Investigators to the China Super Buffet in reference to an Officer involved shooting. I arrived on scene and was tasked with canvassing for surveillance video. I noted exterior cameras at Denny's located at 2690 N Monroe Street, China Super Buffet located at 2698 N Monroe Street, Circle K located at 2683 N Monroe Street, and North Florida Animal Hospital located at 2701 N Monroe Street.

Denny's and Super China Buffet were closed during my presence. I spoke with the nightshift clerks at Circle K. The clerks advised they did not have access to the surveillance system, but a manager would be in at 8:00am that morning. I contacted a vet tech at North Florida Animal Hospital. The tech advised he did not have access to the surveillance system, but he would make notifications to the owners in the morning.

I completed canvassing all surround buildings and was tasked with creating a photographic lineup once the identity of the deceased was. I received notification from Sgt. Butler of the deceased name, Woodard Cleveland Wilbon. Wilbon did not have any CJIS history thus I used his DAVID photograph. I then selected five random white males between the ages of 65-75 with the last name of Smith. I completed two photographic line up packets and responded to the incident scene. I provided Inv. Isaacs with the photographic lineup one at a time and retrieved them back after she had completed the process. I impounded the lineups under TPD case number 20-78835. 2020-CA-1011

I returned to the incident scene later in the morning to review surveillance video from the neighboring businesses. I made contact with Circle K manager, Patrice Richardson, at the store. Richardson allowed me access to the system. I reviewed the surveillance footage and noted the following.

Victim Haines is observed crossing N Monroe Street from China Super Buffet towards Circle K with the assistance of an unknown white male. Haines walks to the parking requesting help. There was a store clerk in the parking lot sweeping at the time Haines requested help. The clerk dialed 911 and requested assistance. Video shows [redacted] and DeGraw arriving on scene along with Leon County Emergency Medical Services. LCEMS tends to Haines as [redacted] drives his patrol vehicle to the China Super Buffet and parks under the awning with his headlights on. Video shows [redacted] using his flashlight and then a stream of emergency vehicles approaching. I exported the video to a hard drive and departed.

I made contacted with staff at North Florida Animal Hospital. I reviewed their footage from the north door camera. The quality of the footage was poor and had the same angel as Circle K. I did not collect the video footage due to the poor quality and unable to see any relevant to the incident.

I proceeded to the Denny's, which is just south of the incident location. I reviewed their live stream of the exterior camera. A large tree was blocking the view of the incident location, thus I did not review the footage from the incident.

I returned to the station and burned the Circle K footage to a DVD. The DVD was impounded as evidence

under TPD case number 20-78840.

I contacted the owner of China Super Buffet. I was advised the business does have exterior cameras, but the business had been closed since March 17, 2020 due to COVID-19. I expressed the importance to view the surveillance cameras due to the incident being captured on their cameras. I was told they would review the surveillance cameras as soon as possible. Follow up will continue to review the China Super Buffet cameras.

This concludes my involvement in this case.

On Tuesday, May 19, 2020 at 1:40am I responded to 2698 North Monroe Street in reference to a shooting incident that just occurred.

I arrived on scene and was directed by Sgt. Abney #234 to canvass the Circle K located at 2415 N Monroe Street. During this time, I made contact with Steve Fairbanks (identified by his New York Driver's License) sitting along the sidewalk. Fairbanks advised he knew some information about the incident that had taken place. Fairbanks stated an unnamed subject was screaming in the area of Circle K that someone "poked out my eye!" Fairbanks stated the subject was bleeding from his face and had a cut on his arm. Fairbanks said he saw two subjects during this time that may have been involved in the initial attack, but he could not identify them. Fairbanks said he began to walk southbound on North Monroe street when he started to hear gunfire. Fairbanks said he heard between six to eight shots. I stood by with Fairbanks until Investigator Covan arrived on scene and began interviewing him.

During the investigation, I also found and guarded a dark colored bag in the Circle K parking lot that possibly belonged to one of the involved parties. The bag was located in the southwest part of the gas station. I was eventually relieved of this duty and released from the scene.

The entire call for service was captured on my body worn camera. Officer T. Johnson # 302 was present with me at the scene the entire time, acting in the role of my Field Training Officer. I was relieved by Officer Smidt #337. This concludes my involvement in this case.

On 05/19/2020 at approximately 1:40 AM, I responded to 2698 North Monroe Street (Super China Buffet) to assist officers with shots fired.

Upon my arrival to the scene, I was tasked with ensuring no subjects were near the outside perimeter of the Super China Buffet. I noted a small dog (unknown type) on a leash near the entrance of the Super China Buffet however it quickly ran away from me. Once the scene was secured, I assisted by assembling a department issued partition to shield the deceased from the view of passing motorists.

Officers relayed over the radio about a possible witness to the shooting across the street at the Circle K. I began speaking with the female, Deanna O'neal who advised me of the following:

She is currently homeless and has began to know a male, Richard "Jack" Haines through friends. She described Haines as an older white male in his 60's with a long white beard and hair. Haines was wearing brown shorts and an unknown color shirt. At approximately 7:30 PM, she stopped by to check on Haines who was drinking Budweiser beer at the Super China Buffet with a male she'd never seen before.

O'neal described the other male of being in his fifties with short hair (possibly balding). He was wearing a blue button up shirt and blue jeans. The male also had a small dog with him.

The male Haines was drinking with was very rude to O'neal and was saying very vulgar things to her.

O'neal left Super China Buffet to go to the store and when she briefly returned, she noticed a white male (described as being husky) with long white hair sitting with them. O'neal left again to go to her motel room at the La Casa to go to sleep.

She was awoken with the word someone had been shot and believed Haines was deceased. I informed O'neal that Haines was in fact ok and was being evaluated at the hospital. She requested his phone be brought to him at the hospital stating "Casey" had his phone.

O'neal summoned Casey to the scene to return Haines' phone.

I began speaking with "Casey" (later positively identified as Casey Durrance by his DAVID photo). Casey explained the following to me:

He knows Haines through O'neal and began hanging out with Haines at the Super China Buffet along with another male. He'd never seen the other male before, however described him as a white male being "a little taller than him" (approximately 5'11"). The male had short hair and was possibly balding. He also advised this male had a small dog with him.

The three began drinking at the Super China Buffet until the male with the dog thought Haines said something about him. The unknown male began fighting with Haines by punching him multiple times with a closed fist. The unknown male tackled Haines to the ground and began attempting to gouge his eyes. Haines

began to scream "I can't see".

Durrance was able to separate the fight where the unknown male walked away, north on Monroe. Durrance assisted Haines across the street to the Circle K to call for help. He returned back to the Super China Buffett to gather Haines' belongings and drop them off to Haines. He stated he did not want to stay at the Circle K due to a previous trespass warning.

Investigator Covan arrived on scene and spoke to both O'neal and Durrance.

O'neal stated she is currently staying at the La Casa Inn room 226 however will be leaving the room in the morning.

Durrance told me he is currently homeless and does not have a specific location. He provided a text now number of (850)898-2615 and an email of caseydurrance668@gmail.com

All actions of mine were captured via my body worn camera. This concludes my involvement in this investigation.

On May 19, 2020 at approximately 1:40 a.m. I was sitting at 1925 N Monroe St when I heard an officer indicate shots were fired at his location. The officer, Ofc. Degraw #509 was on a call at 2683 N Monroe St (Circle K). Further information indicated that the officers were at Super China Buffet (2698 N Monroe St). I responded in emergency mode and activated my body worn camera.

When I arrived, I parked at the Southern entrance to Super China Buffet's parking lot and ran towards the Northern entrance. I observed a white male laying on the ground with a hole in his forehead, blood on the ground beneath his head, and blood on one of his arms. I also observed a medium sized hunting-style knife laying near his head (the knife had a brown handle and silver blade). The male's head was facing East and his body was laying in the center of the Northern entrance's driveway.

A member of the Leon County EMS was on scene. He advised the male was deceased. As the male showed no signs of life, the knife was not moved. I observed two empty knife sheaths on the male's waistband.

I directed two officers to clear the rest of the building. When Ofc. Taylor #712 went to the Northern side of the building, a small black dog ran out dragging a long chain behind him. The dog barked and then ran South and disappeared.

Ofc. White #691 and I put up the privacy screens and placed them around the body with approximately a one foot distance between the screens and the deceased.

I observed a shell casing near the edge of the driveway by the road, as such the crime scene was expanded to include the entirety of Southbound Monroe St. I observed a shell casing directly to the South of the deceased and another Southwest of the deceased, both on the pavement of the driveway.

Once the crime scene was established, I deactivated my body worn camera. This was the end of my involvement in this case.

I did not review any of my body camera footage prior to writing this report. This report was written solely from my recollection of the incident.

On May 19, 2020, I was notified an officer involved shooting had occurred and was requested to respond to Tallahassee Police Department headquarters. 2020-CA-1011

Upon arrival, I gathered the necessary equipment (new duty handgun) and responded to the Criminal Investigations Bureau's conference room.

Inside the conference room, involved 2020CA1011 CA1011 was present as well as the following: Officer Richard Murphy (Police Benevolent Association President), Investigator Amanda Bailey, Forensic Technician Vernon Henderson, Sergeant Ginny Osborn, Internal Affairs Investigator Mark Adrick, Major Shane Porter, Deputy Chief Jason Laursen, Officer Josh Armstrong (Buddy Officer), Training Section Officer Justin French.

All of the above persons were present and witnessed all of my actions and duties as I fulfilled my role as a Training Section member responding to an officer involved shooting.

At 3:15 am, I put on fresh protective gloves as I retrieved duty pistol from the holster. I removed the magazine and safely ejected a live round out of the chamber. I placed the pistol, live round from the pistol chamber and magazine on a paper bag (provided to me by Forensic Technician Henderson) which was sitting on the conference table. I changed into fresh protective gloves and began the round count of the magazine that was in the pistol. I counted aloud for all persons present to hear and counted each round one by one. The total rounds counted in the magazine from the pistol was 8 rounds, plus the round in the chamber, equals 9 total rounds in the pistol. After I conducted the round count, the pistol, the live round from the chamber, the magazine and rounds from the magazine were all turned over to Forensic Technician Henderson who collected them as evidence.

I changed into new protective gloves and removed pistol magazine that was closest to his belt buckle from the pouch on his belt. I counted aloud each round one by one, placing them on a new paper bag which was laying on the conference room table. The total rounds in that magazine were 15. I turned over the 15 rounds and empty magazine to Forensic Technician Henderson who collected them as evidence.

I changed into new protective gloves and removed pistol magazine that was furthest from his belt buckle from the pouch on his belt. I counted aloud each round one by one, placing them on a new paper bag which was laying on the conference room table. The total rounds in that magazine were 15. I turned over the 15 rounds and empty magazine to Forensic Technician Henderson who collected them as evidence.

I issued CA1011 a new duty pistol, with a round in the chamber, and three full magazines

CIB SUPPLEMENTAL REPORT- INVESTIGATIVE SUMMARY:

On May 19th, 2020 at 2:00 AM I was made aware of this investigation by the Violent Crime Unit supervisor Sergeant Butler. Sergeant Butler provided me with a brief summary of an officer involved shooting to include the location. I was assigned as the lead investigator and responded to incident location.

The shooting occurred at 2698 North Monroe Street. 2698 North Monroe Street was the China Super Buffet restaurant. I arrived at approximately 2:45 AM. When I arrived, I observed multiple marked Tallahassee Police Department vehicles. A perimeter was established around the business. Crime scene tape was used to physically mark the boundaries of the perimeter. Officer C. Taylor maintained a crime scene log of persons who entered the perimeter.

After I arrived, I received an update from Sergeant Butler. I learned Officers E. DeGraw and CA1011 responded to a call for service at the Circle K located at 2683 N. Monroe Street. The Circle K was across the street from the China Super Buffet. The Circle K was on the east side of Monroe Street while the China Super Buffet was on the west side of Monroe Street. The initial call for service referenced an Aggravated Battery. The victim was transported to the Tallahassee Memorial Hospital by Leon County Emergency Medical Services. The battery occurred outside the China Super Buffet. CA1011 drove his marked police vehicle from the Circle K to the China Super Buffet where he searched for the victim's property. It was believed 2020-CA-01011 located the suspect who was armed with a knife. The suspect assaulted CA1011 who in response shot the suspect. The suspect was struck by the gunfire and died as a result.

Investigators S. Bennett, D. Covan, A. Bailey, and R. Sullivan responded to assist. Investigator K. Isaacs would respond later to assist with this investigation. Investigator D. Covan was initially responsible for furthering the initial Aggravated Battery investigation which necessitated the call for service. Investigator S. Bennett responded to the Tallahassee Memorial Hospital and interviewed the victim of the preceding aggravated battery. Investigator A. Bailey responded to the police department and facilitated the round count procedure with involved CA1011. Investigator A. Bailey also interviewed Officer DeGraw who initially responded to the report of the Aggravated Battery at the Circle K. Investigator R. Sullivan canvassed and collected video evidence. Forensic Technician J. Sitero and I examined the crime scene.

At 1:29 AM, Officer DeGraw arrived at the Circle K. At 1:31 AM, Officer DeGraw relayed it was safe for Leon County Emergency Medical Services (EMS) to approach. At 1:32 AM, CA1011 was dispatched to the Circle K as backup. CA1011 arrived at the Circle K at 1:33 AM. Leon County EMS arrived at 1:37 AM. At 1:39 AM, CA1011 notified dispatch "shots fired." Leon County Medic Unit 26 requested an additional unit to respond for the Officer Involved Shooting. At 1:42 AM Medic 26 canceled the request for an additional medical unit because the suspect was deceased. The run number (number used to associate a medical transport) for the victim for the initial call for service was EM-20-0016974.

Victim Richard Haines

Officer E. DeGraw authored a report which documented the original complainant by Richard Haines. Officer DeGraw noted victim Haines had blood on his knees, elbows, and around his eyes. Haines told Officer DeGraw he knew the suspect as "William." Haines provided a verbal summary of the offense. Haines and "William" were across the street (from the Circle K) at the China Super Buffet (located at 2698 North Monroe Street).

Haines said "William" had two hunting style knives attached to his hip. Haines said he witnessed "William" use the knives to threaten others. At some point, "William" threatened Haines with one of the knives. Specifically, Haines said "William" made the verbal threat, "I'll cut you, I'll kill you." Haines confronted "William" about using knives to threaten people. This caused "William" to batter Haines. Haines defended himself and described being in a fight with "William." During the fight Haines said "William" used his fingers and gouged his eyes. Haines' visible injuries were consistent with his account. Because of the severity of the injuries, Haines was treated by Leon County EMS on scene and transported to the Tallahassee Memorial Hospital for advanced treatment.

Officer C. Baldwin and Violent Crime Unit Investigator S. Bennett would respond to the Tallahassee Memorial Hospital and conduct additional interviews with victim Haines. Officer Baldwin met Haines in emergency room number 30. Officer Baldwin noted Haines bled from injuries on his left and right hands, the upper portion of his right arm, and his left and right knees. Officer Baldwin documented Haines was barely able to open his eyes and noted injuries which surrounded his left and right eyes. Haines provided a consistent account of the battery to Officer Baldwin. In addition to information

Haines previously provided to Officer DeGraw, Haines said the knives William possessed were in sheaths. During the battery, Haines added how he was on the ground as it occurred. When asked why "William" didn't use the knives, Haines explained he physically held onto the knives (while they were inside the sheaths) to prevent "William" from retrieving them. Haines described "William" as a white male approximately 71 years old.

Richard Haines' Physical Injuries

Forensic Technician K. Stevens responded to the Tallahassee Memorial Hospital and took forensic images of victim Haines' injuries. I reviewed the images. Victim Haines sat on a hospital bed and had what appeared to be dried blood on his left and right knees. Abrasions were visible on each knee and appeared to be the source of the suspected blood. Suspected dried blood was visible on Haines' left hand (Image: KFJ29385). Haines had what appeared to be a small laceration to the right of his right eye. Suspected dried blood and bruising was visible on either side of Haines' right eye. Suspected blood was captured between the right side of Haines' left eye and his nose. There was a small laceration immediately left of Haines' left eye. There was a horizontal laceration on the left side of Haines' face beginning at the center of the left side of his nose. The laceration continued at a downward angle towards Haines' mouth (Image: K5J29389).

Haines' right hand had an abrasion and suspected dried blood between his middle finger and ring/4th finger (Image: K5J29390). A scaled image was taken to document the injury to Haines' left hand. Haines had an abrasion on his left hand above his knuckles but below his wrist; it was surrounded by suspected blood. There was an abrasion on Haines' left hand between his pointer finger and middle finger (Image: K5J29392).

In addition to reviewing the forensic images taken at the hospital, I reviewed Officer DeGraw's body camera video footage as he was the first officer to have contact with victim Haines. Based on the video, Haines had visible injury to both of his knees. Suspected blood was on both knees. Officer DeGraw used a flashlight to illuminate Haines' face. Haines left eye appeared to bleed and suspected blood covered the left portion of Haines' face beneath his eye and to the left of his nose. Haines left hand appeared to be injured as suspected blood covered the center of the top of his hand. Haines pulled up his right sleeve and had a visible injury to his right elbow also covered in suspected blood.

Haines' injuries as captured on Officer DeGraw's body worn camera and in forensic images at the hospital were consistent of his account of being battered. Moreover, the injuries inflicted to Haines'

eyes support his account the suspect used his fingers to "gouge" his eyes.

Victim Casey Durrance

Investigator D. Covan contacted and interviewed Casey Durrance. Durrance was in possession of victim Haines' cellphone and provided it to Investigator Covan. Durrance said he was friends with victim Haines. On the previous date between 5:30 PM and 6:00 PM Haines invited Durrance to the China Super Buffet. Durrance learned the suspect purchased Pizzas to share. Durrance, Haines, and the suspect "hung out" outside the front of the business. As the three men associated, the suspect consumed multiple beers. As this progressed, Durrance said the suspect became belligerent. At some point after the suspect became belligerent, he attempted to strike Durrance and Haines had to intervene. Durrance described the suspect as suffering a mental health issue. Durrance described how the suspect would speak to an imaginary person.

The suspect became verbally hostile towards Haines. Durrance said the hostility was unprovoked. Haines verbally confronted the suspect about his aggressive actions. The suspect escalated and physically attacked Haines. Durrance witnessed the suspect physically punch Haines repeatedly in the face. Haines was tackled by the suspect and landed on the ground. While on the ground, the suspect mounted Haines and stuck his thumbs into Haines' eyes. Durrance said he believed the suspect attempted to gouge out Haines' eyes. Durrance verbally intervened and told the suspect not to gouge Haines' eyes. Haines was able to free himself and roll away from the suspect. Thereafter, Durrance stepped between the suspect and Haines. He told the suspect the fight was over.

Durrance physically assisted Haines across the street to the Circle K. Durrance returned to the Super China to retrieve Haines' belongings. When he returned, Durrance said he found a knife with a black handle on the ground where Haines was attacked by the suspect. Durrance gathered some of Haines' belongings and brought them to him. Haines realized his cellular phone was missing. Durrance returned to the China Super Buffet to collect Haines' phone. The suspect emerged from behind the northeast corner of the business. Durrance said the suspect had a knife in his hand. The suspect repeatedly called Durrance a "bitch" and aggressed him with the knife in hand. The suspect told Durrance he was going to "get him." The suspect pointed the knife at Durrance and Durrance believed the suspect was going to stab him. Durrance fled and walked north on Monroe Street. As Durrance continued to walk north on Monroe Street he said he heard gunshots from the area of the China Super Buffet. During his account, Durrance provided a description for the suspect.

Witness Interviews

Investigator Covan conducted witness interviews with Steve Fairbanks, Deanna O’Neal, and James Grant. These were conducted on May 19th, 2020. The interviews were recorded.

Witness Steve Fairbanks

Fairbanks said he was across the street from the China Super Buffet seated outside the Circle K. Fairbanks said he heard yelling and screaming from the China Super Buffet. Fairbanks interpreted what he heard to be a verbal altercation. Thereafter, he observed two males walk from the China Super Buffet to the Circle K. The males were determined to be Haines Durrance. Fairbanks said one of the males bled from his eyes. The male with the injury to his eyes said repeatedly someone tried to poke his eyes out.

Witness Deanna O’Neal

Deanna O’Neal said her boyfriend was James Grant. O’Neal said she knew Haines. Before the altercation O’Neal said she and Grant stopped at the China Super Buffet. O’Neal said Haines was outside the China Super Buffet with a male unknown to her. The unknown male and Haines consumed beers together. The unknown male was belligerent and wanted to have sex with O’Neal. O’Neal and Grant continued to a nearby business. After they left the business, they returned to the China Super Buffet. O’Neal spoke with Haines while Grant spoke with the unknown male. Thereafter, they continued to walk towards their hotel and Grant told O’Neal the unknown male “pulled a knife on him.”

Witness James Grant

Grant told Investigator Covan he was deaf. Grant’s account of movements with O’Neal were consistent with the information provided by O’Neal. Grant said the unknown male had a dog and Grant purchased food at the convenience store for the dog. After they returned to the China Super Buffet from the convenience store, Grant gave the unknown male the dog food he purchased. Grant attempted to read the unknown male’s lips but had difficulty because the unknown male smoked a cigarette. Grant’s inability to communicate effectively with the unknown male appeared to anger the male. The unknown male retrieved two knives and pointed them at Grant. Grant said he did not feel threatened by the unknown male. Grant described the unknown male as a white male with a short beard.

Witness Paramedic Jason Perez

On May 20th, 2020, Investigator A. Bailey and I conducted a video recorded interview with Leon County Medical Services responder Jason Perez. The interview was video recorded, and Perez was placed under oath at the onset. Perez said he was assigned to Medic 26 at the time of the officer involved shooting.

Perez was a certified paramedic. Perez confirmed his unit responded to the Circle K for an assault. Perez's partner on Medical 26 was Zane Ahmad. When Medic 26 arrived, Perez observed a male with blood on his face and knees speaking with two Tallahassee Police Officers (Officers DeGraw and CA1011). Perez was present and heard the male victim explain to officers he was assaulted, the suspect took some of the victim's belongings, and that he needed medical care. Perez said he heard the patient tell officers the suspect was armed with a knife and attempted to kill him. Perez knew the patient was concerned over the whereabouts of his phone. Perez was unable to recall the name of the victim/patient. Perez said Medic 26 transported the patient to the Tallahassee Memorial for treatment.

I asked Perez if he recalled anything significant that occurred before the transport. Perez reiterated what he had told me but added additional information. After the patient referenced the loss of his phone, Perez said one of the TPD officers said he would look for the missing phone. That officer (CA1011) drove across the street (to the China Super Buffet). The other TPD officer (Officer DeGraw) remained with the victim and Medic 26. Perez escorted the patient to the ambulance. Perez was outside of the ambulance when he heard "three shots or so." When this occurred, the patient and Ahmad were inside the ambulance. Perez said he pondered, "what was that noise." He then heard "get on the ground get on the ground." Perez heard "three or four more shots." After the gunshots, the officer who remained with Medic 26 left to assist the officer who drove across the street.

Perez said he realized what occurred, notified dispatch, and requested a second Medic unit to respond to assist. Perez retrieved his medical equipment and walked to the China Super Buffet. When he arrived, he said a female TPD supervisor (Sergeant Connell) told Perez not to touch the person who was shot as he was deceased. Perez said he observed a gunshot to the deceased's head and he was "obviously signal seven (code for deceased person)." Perez said when he went to the China Super Buffet and approached the deceased, he observed a knife on the ground next to him. Perez said when he arrived at the China Super Buffet, he described seeing four TPD officers. Perez said two of the officers were the two officers he had initial contact with at the Circle K for the

original assault call (Officer DeGraw and CA1011).

Based on what Perez witnessed he told me he concluded the suspect remained concealed in the bushes and attacked the TPD officer with the knife. It was clear Perez did not witness this but concluded this based on his observations and information provided by victim Haines.

Photo Lineups

I requested Investigator R. Sullivan to create a photographic lineup to include Wilbon Woodard. Woodard was identified as the suspect who was shot by CA1011. Woodard matched the description of the suspect who attacked victim Haines. Investigator Sullivan provided lineup packets to Investigator K. Isaacs. Investigator K. Isaacs had not participated in the investigation to this point and her first assignment was to present the independent lineups to victim Haines and Durrance. Investigator Isaacs did not know Woodard's identity when she presented the lineups. Durrance positively identified Woodard as the suspect who battered Haines and who assaulted him with a knife. The process was recorded.

Despite the injury to his eyes, Haines said he wanted to view the lineups. Haines was unable to make an identification and complained of difficulty being able to see due to his injuries. The process was recorded.

Disposition of Original Call for Service (TPD 20-078835)

Based on the facts and circumstances, Woodard and Haines congregated at the China Super Buffet where they consumed Pizza and alcoholic beverages together. At some point Haines invited Durrance to the China Super Buffet to join them. Durrance responded to the closed business and congregated with Haines and Woodard. As they socialized, O'Neal and Grant stopped by on their way to a convenience store. At the store, they purchased dog food and returned to the China Super Buffet. Grant provided the dog food to Woodard. At some point Woodard became frustrated and pointed two knives at Grant. Despite Woodard's actions, Grant said he was not fearful. O'Neal and Grant left the China Super Buffet.

Woodard became increasingly belligerent and verbally attacked Haines. Ultimately Woodard repeatedly punched Haines in the face and tackled him to the ground. This was witnessed by Durrance. As the attack continued, Woodard forced his thumbs into Haines' eye sockets. Haines freed himself and Woodard pursued him. Durrance stepped between Woodard and Haines to prevent any further attack. Durrance assisted Haines across Monroe Street to the Circle K parking

lot to seek assistance.

Durrance returned to the China Super Buffet to retrieve Haines' property. As he searched for Haines' cellular phone, Woodard emerged from behind the northeast corner of the business armed with a knife. Woodard threatened Durrance with the knife and Durrance fled from the area.

Officer DeGraw and Leon County Emergency Medical Services respond. Haines had visible injuries consistent with the attack as described by Haines and Durrance. Those injuries were captured on body worn camera and by forensic images taken at the Tallahassee Memorial Hospital. Woodard was positively identified in an independent lineup by Durrance. Physical evidence discovered during the on-scene investigation for the Officer Involved Shooting included displaced items and suspected blood as evidence of the attack. The pizza boxes, discarded beer cans, and dog food corroborated the circumstances which surrounded the attack. Woodard was found with two knife sheaths and a knife next to his person which supported the information provided to investigators.

Based on the evidence obtained in the investigation of the reported incident which precipitated the officer involved shooting, probable cause would have existed to charge Woodard with Aggravated Battery pursuant to FSS: 784.045 for inflicting great bodily harm on Haines to include diminishing his ability to see. Probable cause would have existed to charge Woodard with Aggravated Assault with a Deadly Weapon for using a knife to threaten to "get" Durrance. The investigation is Exceptionally Cleared- Death of Offender.

Video Footage from the Circle K (2683 North Monroe Street)

Investigator R. Sullivan obtained the video footage for the Circle K pursuant to this investigation. The footage was impounded as evidence. The footage included recordings from twelve different cameras. Only three of the cameras captured the exterior of the business and had relevance to this investigation. I reviewed the footage and summarized it below. The times are based on the displayed time within the footage.

"Front Walk Camera" (South East field of view):

- 1:29:16 Haines approached the curb in front of the Circle K
- 1:29:37 Haines sought assistance from an unknown black male

"Pumps One Camera" (Due West field of view):

- 1:18:21 Haines first appeared and walked into Circle K parking lot from the area behind

The video footage from the Circle K support Haines' account of events after he fled from the China Super Buffet after the attack. Haines appeared injured based on his movements. Haines requested Circle K personnel to summon law enforcement and report the attack.

The video footage captured events relevant to the Officer Involved Shooting. Based on the video Officer DeGraw arrived at 1:29:12. After arrival, Officer DeGraw met with victim Haines. Officer arrived at 1:33:55; 4 minutes and 43 seconds after Officer DeGraw arrived. Officer approached Officer DeGraw and victim Haines. 2020-CA-01011 was in a place where he could hear the information Haines provided to Officer DeGraw about the attack. At 1:37:30, 3 minutes and 45 seconds after he arrived, Officer left the Circle K and drove towards the China Super Buffet. At 1:37:50 the head and tail/brake lights on Officer vehicle were no longer visible after it appeared to enter the China Super Buffet parking lot. At 1:38:53, 1 minute and 3 seconds after the head and tail/brake lights on Officer vehicle were no longer visible, Officer DeGraw ran from the ambulance parked at the Circle K towards the China Super Buffet. Officer DeGraw's actions were indicative of being made aware of the officer involved shooting and responding to the area/ China Super Buffet.

Body Worn Camera Footage

As part of this investigation I reviewed the body worn camera footage for officers who responded to the officer involved shooting. Footage was uploaded and associated to CN: 20-00078835 and 20-00078840. 20-00078835 was the case number associated to the original call for service while 20-00078840 was associated specifically to the investigation of Officer shooting. During the review, Officers DeGraw and were captured in each other's footage. The footage demonstrated both officers wore standard issue department uniforms. The uniforms include a prominent police department badge and police department shoulder patches. Based on their dress, Officer DeGraw and Officer were visually recognizable as uniformed police officers.

Officer E. DeGraw (BWC) Axon Flex 2 X83042536

Officer DeGraw's body worn camera footage for this investigation began on May 19th, 2020 at 1:29 AM. The footage was 17 minutes and 4 seconds in length. It was uploaded on May 19th, 2020 at 5:11 AM. GPS data was associated to the video. The start location for the recording was approximated to be 2701 N Monroe Street. The GPS data recorded the movements of Officer

DeGraw which included crossing North Monroe Street to the area of the China Super Buffet.

At plus 20 seconds Officer DeGraw pulled his patrol vehicle into the Circle K parking lot. At plus 30 seconds the audio was activated. This was consistent with the 30 second buffer enabled on all Tallahassee Police Department body worn cameras. At plus 40 seconds Officer DeGraw had contact with victim Haines. Victim Haines immediately stated, "there's a knife over there."

Haines was accompanied by the unidentified black male who walked from the area. Officer DeGraw walked with Haines to the area of his patrol vehicle. Haines' injuries were visible in the footage. Haines' told Officer DeGraw, "he jumped on me" and "he pulled a knife he has two buck knives on him (plus 57 seconds)". Haines detailed the manner in which he was attacked. Haines specified how "he" the suspect used his fingers to "poke my eyes out" (plus 1 minute and 9 seconds).

Haines pointed to the area of the China Super Buffet and told Officer DeGraw the suspect was located there. Officer DeGraw requested EMS to respond and described Haines' injuries. (plus 1 minute and 39 seconds). When Officer DeGraw asked Haines the location of the suspect, Haines responded "that abandon building over there, that restaurant Chinese" (plus 2 minutes and 7 seconds). Haines added the suspect was outside the building. Haines continued to provide an account of what occurred. This included how the suspect threatened "the black guy with his knife" (plus 2 minutes and 25 seconds). Haines told Officer DeGraw the unidentified black male who accompanied him and walked off was the person who the suspect threatened with a knife (plus 2 minutes and 34 seconds).

Haines explained he encouraged the suspect not to threaten others which lead to the suspect attacking him. Haines reiterated how the suspect was armed with two knives. During the attack Haines said the suspect attempted to retrieve a knife. Officer DeGraw requested a backup officer via radio (plus 2 minutes and 59 seconds). Haines provided Officer DeGraw with a description of the suspect. Haines provided additional details of the events which occurred before and during the attack (plus 5 minutes and 0 seconds).

Officer arrived and stood next to Officer DeGraw's patrol vehicle while Haines continued to detail the attack (plus 5 minutes and 15 seconds). Officer was able to overhear the details of the attack as conveyed to Officer DeGraw by victim Haines after this point. Haines told Officer DeGraw the armed suspect said, "I'll cut you, I'll kill you." Officer DeGraw asked Haines if the suspect had the knives in his hands when the threat was made, and Haines responded affirmatively. Officer DeGraw summarized the details of the attack as conveyed by Haines. Haines confirmed the

details were accurate and reiterated how the suspect injured his eyes during the attack. Haines told Officer DeGraw the suspect's name was "William" (plus 6 minutes and 18 seconds).

Officer DeGraw asked Haines for his personal identifying and contact information. This included a request for Haines' phone number. Haines told Officer DeGraw his phone was "over there" and referenced the China Super Buffet (plus 6 minutes and 47 seconds). Officer DeGraw asked Officer if he would mind going to the China Super Buffet. Officer asked Officer DeGraw for suspect information; "what's your suspect" (plus 7 minutes and 15 seconds). Officer DeGraw described the suspect to 2020-CA-01011. Officer asked victim Haines information about his missing phone. Victim Haines asked Officer , "go find my phone please" (plus 7 minutes and 50 seconds). Officer walked from Officer DeGraw's patrol vehicle towards his patrol vehicle. Officer DeGraw told Haines EMS had arrived.

Officer DeGraw provided responding EMS personnel with an overview of victim Haines' injuries and the manner in which they were inflicted. Officer patrol vehicle drove out of the field of view of Officer DeGraw's body camera (plus 8 minutes and 16 seconds). EMS used a light to illuminate Haines' eyes and immediately requested to transport him to the hospital. Haines reiterated he wanted his phone before he was transported. Officer DeGraw followed Haines to the ambulance (plus 9 minutes and 24 seconds).

Loud shouting can be heard in the background (Officer) and Officer DeGraw told EMS he was going to "run across the street" (plus 9 minutes 45 seconds). As Officer DeGraw walked west towards the China Super Buffet additional shouting was recorded. The command "drop it now!" was clearly distinguished (plus 9 minutes and 48 seconds). Two gunshots were clearly distinguished (plus 9 minutes and 49 seconds). Officer DeGraw increased his speed and ran towards the China Super Buffet. Two additional gun shots were clearly distinguished (plus 9 minutes and 50 seconds). Officer DeGraw continued to run towards the China Super Buffet. Three additional distinguishable gunshots are heard (plus 9 minutes and 54 seconds).

Officer DeGraw radioed "shots fired" and provided the location as the China Super Buffet. Officer DeGraw ran across North Monroe Street (plus 9 minutes and 57 seconds) as he made the radio transmission. Officer DeGraw arrived in the northern drive to the China Super Buffet and used his flashlight to illuminate the area. A white male was captured on the ground. Officer DeGraw asked Officer , "you got him?" Officer responded, "I got him" (plus 10 minutes and 8 seconds). Officer said "there's the knife right there. He just ran at me with the knife" (plus 10 minutes and 12 seconds). Officer DeGraw asked Officer if he was "alright." Officer responded

affirmatively and added "he wouldn't show me his hands."

Officer DeGraw donned department provided latex gloves. Officer asked if EMS was going to respond. Officer DeGraw radioed the need for EMS to respond (plus 10 minutes 46 seconds). Officer DeGraw used a flashlight to illuminate the suspect. The suspect laid on his left side with his left arm extended above his head. A straight edged knife with a brown handle was on the ground next to the suspect's extended left arm. A pool of suspected blood was on the ground adjacent to the suspect's head (plus 10 minutes and 54 seconds).

Officer DeGraw secured the suspect in handcuffs (plus 11 minutes and 28 seconds). Additional patrol vehicles with activated emergency lights and sirens arrived (plus 11 minutes and 36 seconds). Patrol supervisor Sergeant K. Connell asked what they needed to look for (plus 11 minutes and 50 seconds). Officer informed Sergeant Connell there were no outstanding suspects and explained the suspect "ran at me with a knife." Officer DeGraw stated EMS arrived (plus 12 minutes and 11 seconds). Officer DeGraw relayed the suspect had a "GSW" (gunshot wound) to the head. Sergeant Connell told EMS they did not need to touch the suspect and implied he was deceased.

Officer DeGraw relayed information to Sergeant Connell about the size and location of the crime scene. Sergeant Connell asked Officer DeGraw if he was involved. Officer DeGraw explained he was not involved (did not discharge his firearm) (plus 12 minutes and 30 seconds). Sergeant Connell ordered a buddy officer be assigned to Officer . Officer Armstrong was assigned as Officer buddy officer. Officer DeGraw was told by Sergeant Connell to remain outside the crime scene where he remained. Officer DeGraw was initially assigned a buddy officer. Officer Perea remained with Officer DeGraw outside the established crime scene. Patrol supervisor Sergeant D. Northway gave Officer DeGraw permission to stop his body worn camera (plus 17 minutes and 3 seconds).

Officer 2020-CA-1011

Officer had two separate body worn camera videos relevant to this investigation. The first began on May 19th, 2020 at 1:34 AM. The footage was 3 minutes and 28 seconds in length. It was uploaded on May 19th, 2020 at 3:37 AM. No GPS data was captured.

Officer parked his marked patrol vehicle at the Circle K (plus 20 seconds). At plus 30 seconds the audio was activated. This was consistent with the minus 30 second buffer enabled on all Tallahassee Police Department body worn cameras. Officer DeGraw asked victim Haines, "did he pull the knife on you or not." Haines responded affirmatively (plus 35 seconds). Officer DeGraw

asked Haines what “he” the suspect said. Haines responded (the suspect said) “I’ll cut you I’ll kill you.” Officer DeGraw summarized the suspect’s actions to include threatening Haines while armed with a knife and threatening “I’ll cut you I’ll kill you” (plus 54 seconds). The injuries to Haines’ knees were captured and visible to Officer [redacted] based on the field of view from his body worn camera. Haines provided additional details of the attack. This included how the suspect used his fingers to gouge Haines’ eyes. Officer DeGraw reassured Haines medical services were on their way (plus 1 minute and 14 seconds).

Officer DeGraw asked Haines the whereabouts of the suspect. Haines said the suspect was outside the China Super Buffet beneath the overhang (plus 1 minute 28 seconds). Haines said he believed the suspect’s name was “William.” Officer DeGraw asked Haines for identifying and contact information. When asked about a phone number, Haines explained his phone was still at the China Super Buffet (plus 2 minutes 11 seconds). Officer DeGraw asked Officer [redacted] if he would go to the Super Chinese Buffet. Officer [redacted] asked Haines if the suspect was at the restaurant “right here” (plus 2 minutes and 31 seconds). Officer [redacted] asked Officer DeGraw information about the suspect. Officer DeGraw described the suspect for Officer [redacted] (plus 2 minutes 34 seconds). Officer [redacted] asked Haines information about his phone. Haines described his phone.

Officer [redacted] radioed that EMS arrived (plus 3 minutes 13 seconds). Officer [redacted] walked back to his patrol vehicle. Officer [redacted] entered his patrol vehicle (plus 3 minutes 15 seconds). Officer [redacted] was inside his patrol vehicle and stopped the recording function of his body worn camera (plus 3 minutes 28 seconds).

Officer [redacted] second body worn camera video began on May 19th, 2020 at 1:38 AM. It was 3 minutes and 49 seconds in length. It was uploaded on May 19th, 2020 at 3:39 AM. No GPS data was captured.

Officer [redacted] exited his patrol vehicle parked outside the China Super Buffet (plus 1 second). Officer [redacted] walked beneath the overhang outside the main entrance to the China Super Buffet and used a flashlight to illuminate the area (plus 4 seconds). 2020-CA-01011 illuminated the area south of the main entrance where an overturned ashtray and objects were scattered on the ground. Officer [redacted] continued and observed the items immediately outside the doors to the restaurant. He continued to use his flashlight to illuminate the area (plus 14 seconds). Officer [redacted] turned towards the north east corner of the building and used his flashlight to illuminate the area (plus 22 seconds). At plus 30 seconds the audio was activated. This was consistent with the minus 30 second buffer enabled on

all Tallahassee Police Department body worn cameras.

Officer [redacted] used his flashlight to illuminate the shrubbery which paralleled the front northern side of the business. Officer [redacted] directed his light held in his left hand towards the northeastern corner. 2020-CA-01011 gave the verbal command to "come out" (plus 31 seconds). Officer [redacted] adjusted his body position and a white male (suspect) was captured at the northeastern corner of the business. The suspect's left leg, upper torso, and head were now visible. The male said "what" to Officer [redacted]. Officer [redacted] told the suspect, "you're hiding behind some bushes staring at me" (plus 36 seconds).

The suspect said something to Officer [redacted]. Most of the male's statement to Officer [redacted] was uninterpretable (plus 45 seconds). Officer [redacted] stepped toward the corner of the business where the suspect was partially concealed. Officer [redacted] asked the suspect, "why are you hiding in bushes starring at me?" Officer [redacted] ordered the suspect to "come out" (plus 48 seconds). Officer [redacted] walked north and used his light to illuminate the suspect. Most of the suspect was visible except for his right hand which was concealed by the shrubbery. Officer [redacted] ordered the suspect to "step out" (plus 50 seconds).

The suspect used his left hand and motioned towards Officer [redacted] like he invited him to step closer. Officer [redacted] told the suspect to "step out." The suspect's right hand remained concealed. Officer [redacted] ordered the suspect to "get your hand out of the bush right now" (plus 52 seconds). The suspect stepped towards Officer [redacted] (plus 53 seconds). Officer [redacted] ordered the suspect to "get your hand out of the bush" (plus 55 seconds). The suspect increased his speed and charged towards Officer [redacted].

Officer [redacted] stepped backwards and ordered the suspect who charged at him to "drop the [redacted] (uninterpretable)." Officer [redacted] gave the command for the suspect who charged him to "drop the knife drop the knife right now" (plus 58 seconds). Officer [redacted] ordered the suspect twice more to drop the knife and fired two rounds from his handgun at him (1 minute 0 seconds). Officer [redacted] radioed "shots fired!" (plus 1 minute 2 seconds). Officer [redacted] continued to walk backwards from the suspect and fired two additional rounds. The suspect continued to run at Officer [redacted] and said (uninterpretable) "I'll kill yea" (plus 1 minute 5 seconds). The suspect decreased his distance from Officer [redacted]. Officer [redacted] fired three more times at the suspect (plus 1 minute and 6 seconds). Officer [redacted] radioed "shots fired" (plus 1 minute and 7 seconds).

if he "got him" (plus 1 minute 20 seconds). Officer [redacted] activated his weapon mounted light attached to his issued handgun to illuminate the area. The suspect was recorded on the ground with apparent blood near his head. There were no other persons present in the area as recorded in the video. 2020-CA-01011 told Officer DeGraw, "knives right there. He ran at me with the knife" (plus 1 minute and 23 seconds). Officer DeGraw asked 2020-CA-01011 if he was "alright." 2020-CA-01011 responded, "yea I'm fine he ran at me with a knife" (plus 1 minute and 29 seconds). 2020-CA-01011 continued to cover the suspect with his handgun while Officer DeGraw retrieved gloves. 2020-CA-01011 breathed heavily in the footage. Officer DeGraw reassured 2020-CA-01011 "you're good. It's ok" (plus 1 minute and 48 seconds).

2020-CA-01011 asked Officer DeGraw if "EMS is just fucking standing there." Officer DeGraw radioed for EMS to respond. 2020-CA-01011 activated his weapon mounted light for Officer DeGraw. When this occurred, the knife became visible and was on the ground next to the suspect (plus 2 minutes and 1 second). 2020-CA-01011 stepped towards the suspect's head and maintained cover with his handgun while Officer DeGraw secured the suspect in handcuffs (plus 2 minutes and 12 seconds). As Officer DeGraw secured the suspect into handcuffs, an apparent gunshot wound was visible on the top of the suspect's head (plus 2 minutes and 15 seconds). After the suspect was secured in handcuffs, 2020-CA-01011 holstered his handgun (plus 2 minutes and 42 seconds).

Additional patrol vehicles arrived with their sirens and emergency lights activated. 2020-CA-01011 radioed the suspect was "ten-fifteen (secured in handcuffs/under arrest), he's in handcuffs, and got a gunshot to the head" (plus 2 minutes and 50 seconds). Patrol supervisor Sergeant Connell arrived and asked 2020-CA-01011 "what else do we need to be looking for." 2020-CA-01011 responded, "this is it right here." Officer Connell asked, "he did it himself?" 2020-CA-01011 responded, "no- he ran at me with a knife, so I had to shoot him" (plus 3 minutes 2 seconds). Sergeant Connell ordered 2020-CA-01011 a "buddy" officer and told him not to leave Officer [redacted] side. Officer [redacted] assigned buddy officer was Officer Armstrong. 2020-CA-01011 told Officer Armstrong he was unsure if he should deactivate his body worn camera. Officer Armstrong told 2020-CA-01011 he thought he could deactivate his camera (plus 3 minutes and 49 seconds).

Radio Transmissions

I obtained and reviewed the recordings for the radio traffic relevant to the officer involved shooting. The relevant communications occurred on the North West (NW) radio channel. The relevant transmissions occurred between 1:30 AM and 1:57 AM. I summarized the relevant transmissions

Discrepancies in Time and Time-Drift

Significant evidence as to the chronological events which occurred before, during, and after the officer involved shooting were obtained in the form of radio traffic/transmissions (used to create the CAD report) and officer body worn camera footage. During the review of the previously referenced evidence, discrepancies in time stamps were discovered. To illustrate, based on body worn camera footage, Officer DeGraw radioed dispatch at 1:30:39 AM (plus 1 minute and 39 seconds) and requested EMS. Based on the radio transmission and associated metadata, Officer DeGraw made the request for EMS at 1:30:45 AM. Likewise, based on his body worn camera footage 2020-CA-01011 radioed dispatch at 1:40:50 AM (plus 2 minutes and 50 seconds) and relayed the suspect's condition. Based on the radio transmission and associated metadata, 2020-CA-01011 radioed the suspect's

condition at 1:40:41 AM.

To summarize, Officer DeGraw's body worn camera timestamps and Officer [redacted] timestamps differed from the timestamps associated to the radio communications. In the previous illustration, Officer DeGraw had a 6 second difference while 2020-CA-01011 had a 9 second difference. During a previous investigation, contact was made with Axon reference to time disparities in their manufactured body worn cameras. Axon provided an email response which explained based on natural clock drift, the internal clock could drift up to plus or minus 2 minutes per month. This explanation was consistent with the 6 and 9 second disparities observed in this investigation.

~~Crime Scene Examination~~

Forensic Technician Sitero responded to the China Super Buffet after the officer involved shooting and documented the crime scene with forensic images. In addition, the department's FARO system was used to document the scene and create a 3-D rendering. I examined the scene and searched for evidence.

The China Super Buffet was located on the western side of North Monroe Street. There was a driveway located at the northern side of the property. The driveway adjoined North Monroe Street to the parking lot for the business. The initial driveway was perpendicular with North Monroe Street but curved southward. It passed beneath the covered entrance to the business. The front parking lot for the business was located south of the covered entrance. There was a parking lot in front of the business (east). There was a side parking lot located on the southern side of the business. The side and front parking lots were adjoined. There was a southern driveway which adjoined North Monroe Street to the side (southern) parking lot. There was a rear parking lot located behind (west) of the building. It was connected to the southern parking lot. North of the building was a thin tree-line and water drainage area that separated the China Super Buffet from the adjacent business. The tree-line included trees which exceeded the two-story business in height as well as shorter trees and shrubbery. The shrubbery continued across portions of the front (eastern) side of the business and was decorative.

The business was closed and there was no external lighting. There was minimal natural light due to the time of night. Due to the lack of lighting, Forensic Technician Sitero and I had to use flashlights to search the scene for evidence.

Four fired .40 caliber cartridge casings were recovered on the northern driveway to the business. Evidence markers 1-4 were used to mark their locations in the forensic images. There was a marked patrol vehicle parked on the northern driveway for the business. The patrol car was parked south of where the four fired cartridge casings were recovered. A department issued medical bag was on the hood of the car. A fifth fired cartridge casing was located on the northern driveway to the business. Evidence marker 5 was used to mark its location. Two additional fired cartridge casings were discovered further west on the northern driveway. Evidence markers 6 and 7 were used to mark their locations. The deceased suspect was on the ground between recovered cartridge cases 1-4 and 6-7. All seven cartridge casings were chambered for .40 caliber. All seven cartridge casings had "WIN 40 S&W" headstamps. This is consistent with Tallahassee Police Department issued handgun ammunition.

The positioning of the recovered fired cartridge casings and the deceased were indicators of the movements by the deceased and 2020-CA-01011. Recovered cartridge casing 6-7 were located behind (west) of the deceased while recovered cartridge casings 1-4 were recovered in front (east) of the deceased. The positioning supports the deceased moved beyond or past the point where the cartridge casings 6-7 landed after being fired. The positioning of the spent cartridges also supports 2020-CA-01011, who fired the spent cartridge casings, moved east or away from the deceased after he fired. It should be noted the northern driveway where the cartridge casings and the deceased were discovered has a downward angle which degrades from the business to the roadway.

No projectiles were recovered during the on-scene examination. Due to the time of night, a subsequent search was conducted during daylight hours. No projectiles were discovered during the subsequent daylight search.

Additional Crime Scene Examination and Evidence

Outside the main entrance to the business beneath the overhang, various items were located. The items appeared to be transient possessions. Linens for a makeshift bed were immediately outside the main entrance to the business. Partially eaten individual pieces of pizza were on the ground outside the area of the main entrance. A package of dog treats was tucked into a cinder block in the same area as the pizza and linens. Individual dog treats were on the ground in this area as well as discarded containers. To the south of the main entrance was an overturned ashtray. A pizza box and a roll of toilet paper were on the ground. Personal hygiene items were also discovered in this area. On the lip of the southwestern most support beam for the overhang/awning was a package of cigarettes, an umbrella, and an additional roll of toilet paper. Of significance, a straight edged knife

with a black handle was also discovered there.

To the south of the southwestern support beam was a designated area for landscape. The wooden barriers used to contain the landscaping was displaced. A leaf with suspected blood was discovered on the ground adjacent to the displaced wooden barriers. Six discarded beer cans were located outside the business entrance and to the immediate south near the displaced wooden landscape barriers.

The area immediately north of the business was also searched. This included a designated drainage area that was concealed in part by tree-line; the drainage area was perpendicular to the front of the business (east/west orientation). During a search of this area, a box believed to contain fecal matter and used toilet paper was discovered. A makeshift bed was located further west against the northern most wall of the business. The back panel for a cellular phone was discovered on a brick on the northern exterior wall of the business. The cellular phone back had blue tape and the number "274-3110" written on it in black marker. It should be noted this was similar with a handwritten document later discovered in Woodard's wallet (blue tape with black marker with Woodard's handwritten social security number).

A black suitcase was located concealed in the tree-line immediately north of the business. The suitcase contained folded clothing, belt buckle, hair clippers, a phone charger, a pair of scissors, and three fixed blade knives. The recovered suitcase and cellphone backing were believed to belong to Woodard.

Examination and Identification of the Deceased

The deceased was on the northern driveway of the business. Department visual barriers were used to mask the deceased from the motoring public on North Monroe Street. The deceased laid on his stomach with his head oriented towards North Monroe Street with his feet towards the business. The deceased was positioned at a slight angle (head to toe: northeast to southwest). He was in handcuffs with his hands behind his back. His left leg was straight while his right leg was bent at the knee.

The deceased wore blue jeans, black leather styled boots, a brown belt, and a blue long-sleeved button up shirt. A black wallet protruded from his back-right pants pocket. There were two knife sheaths attached to the deceased's brown belt on his right side; one was black and the other was brown. The brown sheath had the name "Wilbon" written on it in black ink.

A brown handled fix bladed knife was on the ground next to the deceased. It was located east of the deceased's head. A blue latex glove like those provided by the police department was on the ground next to the deceased.

Suspected blood was present throughout the deceased's shirt. Larger suspected blood stains were visible on the deceased's right forearm, chest, stomach, left shoulder, inner left thigh, and inner right thigh. Suspected blood was present on the left and right hands of the deceased. The deceased had a visible gunshot wound on the top right half of his head. Suspected blood pooled beneath the deceased's head.

The deceased had swelling and discoloration above each of his orbital sockets. I wore department latex gloves and examined the deceased. His buttoned-up shirt was fastened at the bottom but unbuttoned at the top. I observed a gunshot entry wound to the deceased's chest. I searched the deceased's wallet which contained his Florida Identification Card and his Social Security Card. The Social Security Card was in plastic and had blue tape attached with the number written on it in black ink. \$5,250 in U.S. currency was determined to be contained in the wallet.

The deceased was positively identified as Wilbon Woodard. The identification was visually confirmed with Woodard's identification card and his image in DAVID (taken December 14th, 2019). Woodard's wallet and contents were collected by Forensic Specialist Sitero at the scene. Forensic Specialist Sitero processed Woodard's hands for potential biological evidence. Forensic Specialist Sitero collected a buccal/DNA standard for Woodard.

After Woodard was examined, his remains were sealed in an evidence bag. Department evidence tape was placed over the sealed bag. Woodard was transported to the Medical Examiner's Office where he would be autopsied.

Daylight Crime Scene Examination and Evidence

Due to the lack of natural light during the initial examination of the crime scene it was maintained until it could be searched during daylight hours. Investigators D. Covan, K. Isaacs, M. Ray, and Forensic Technician V. Henderson conducted the daylight search. The exterior of the China Super Buffet and the adjacent northern business (unnamed and currently under construction) were searched for projectiles and impact sites.

During the search, four possible projectile (gunshot) impact locations were discovered. Forensic Technician V. Henderson took images of the possible impact locations. All four locations were

discovered on the southernmost exterior wall of the business located north of the China Super Buffet. The wall was made of brick and painted white. Evidence marker 16 was associated to two possible projectile strikes. Forensic scales were included in the images. Evidence markers 17 and 18 were associated to the additional two possible impact sites. No physical projectiles were recovered.

In addition to the possible projectile strikes, a cellular phone and folding knife were also discovered during the daylight search. Both the phone and knife were discovered on the northern side of the China Super Buffet along the drainage area next to the wood-line. Forensic Specialist V. Henderson took images of the items. Evidence marker 14 was associated to the recovered knife. The knife had a brown handle and the blade was folded in the outward position. Evidence marker 15 was associated to the located cellphone.

FARO Measurements

The crime scene was scanned with the department's 3D imaging FARO system. I was provided with an interactive program which contained the scanned files. I reviewed the renderings. All images appeared to be from an infrared view due to the lack of light when the scans were taken. While the measurements were precise based on the program, due to the infrared imagery, and the precise method of choosing a given point, the accuracy based on the chosen points to demonstrate distances are considered estimates.

Using the Measure Distance application for FARO Scan_005, I measured the closest point of Woodard's body to the north east corner of the business where he initially contacted 2020-CA-01011. Based on the measurement, Woodard traveled approximately 16.751 meters or approximately 57.957 feet as he assaulted 2020-CA-01011 while armed with a knife. There is difficulty determining Officer [redacted] initial location when he had initial contact with Woodard as well as his location after he relocated to better see Woodard. This is because his body worn camera captured a first-person view. Therefore, it is problematic to determine the distance 2020-CA-01011 traveled while he was pursued by Woodard who was armed with a knife. In an effort to make some determination, I measured the distances from Woodard's initial location (northeast corner of the business) to the evidence markers associated to Officer [redacted] recovered cartridge casings. I used FARO Scan_005 and FARO Scan_006 and the distances are listed below:

- Evidence Marker 7 was 14.454 meters (47.421 feet)
- Evidence Marker 6 was 16.313 meters (53.520 feet)

- Evidence Marker 5 was 18.871 meters (61.912 feet)
- Evidence Marker 4 was 20.72 meters (67.979 feet)
- Evidence Marker 3 was 21.935 meters (71.965 feet)
- Evidence Marker 2 was 23.53 meters (77.198 feet)
- Evidence Marker 1 was 24.617 meters (80.7664 feet)

I also used the application to measure the distance between Woodard's western most point (closest to where he had initial contact with 2020-CA-01011 to Evidence Markers 6 and 7. Woodard's body was beyond (east) of recovered fired cartridges casings associated to Evidence Markers 6 and 7. The measurements demonstrate the distance traveled by Woodard past the approximate location 2020-CA-01011 stood when he fired the cartridge cases associated to Evidence Markers 6 and 7. Woodard was 1.077 meters (3.533 feet) beyond Evidence Marker 6. Woodard was 4.035 meters (13.238 feet) beyond Evidence Marker 7. This further supports Woodard's actions as recorded on Officer [redacted] body worn camera; Woodard moved towards 2020-CA-01011 and continued to move towards 2020-CA-01011 after being shot at and while armed with a knife.

I used the FARO application to measure the distance between Woodard's western most point and Evidence Marker 2 which was associated to a recovered fired cartridge casing. Evidence Marker 2 was east of Woodard. The measurement creates an approximate distance between Woodard and the area near 2020-CA-01011 when he discharged the projectile associated to the recovered cartridge casing. There were 6.781 meters (22.247 feet) between Evidence Marker 2 and Woodard.

Evidence Markers 3 and 4 were farther west of Evidence Marker 2. Because of the visual barriers placed around Woodard for dignity purposes, I was unable to use the FARO application to make a single measurement between Evidence Markers 3 and 4. As a next best option to estimate the distances between Evidence Markers 3 and 4 and Woodard's western most point, I measured the distance between Evidence Markers 3 and 4 and the central base of the centermost visual barrier. I then measured the distance between the central base of the centermost visual barrier and Woodard's western most point. I added the sums to estimate the distance between Woodard and Evidence Markers 3 and 4. The measurements create an approximate distance between Woodard and the area near 2020-CA-01011 when he discharged the projectiles associated to the recovered cartridge casings. The distance between Evidence Marker 3 and the center of the centermost visual barrier was 3.013 meters (9.885 feet). The distance from Woodard and the center of the centermost

visual barrier was 2.784 meters (9.133 feet). The estimated distance from Woodard and Evidence Marker 3 was 5.797 meters (19.019 feet). The distance between Evidence Marker 4 and the center of the centermost visual barrier was 3.123 meters (10.246 feet). The distance from Woodard and the center of the centermost visual barrier was 2.784 meters (9.133 feet). The estimated distance from Woodard and Evidence marker 4 was 5.907 meters (19.379 feet). These measurements support 2020-CA-01011 continued to step backwards as he discharged his firearm at Woodard while Woodard continued to approach 2020-CA-01011.

Because Woodard was secured in handcuffs behind his back, I was unable to measure the distance between the knife and Woodard's right hand. The blade was closest to Woodard's head with the handle closer to Monroe Street. I used the FARO application to measure the distance between the tip of the blade and Woodard's closest point (top of head). The distance was minimal: .371 meters (1.217 feet). I measured the distance of the knife recovered immediately next to Woodard. The fixed blade knife measured .257 meters (.843 feet).

Officer 2020CA1011 Round Count Procedure and Issued Equipment

After I arrived at the China Super Buffet to investigate this matter, Sergeant Connell asked if involved 2020-CA-01011 could be transported to the police department (where the round count procedure would occur). 2020-CA-01011 was assigned a "buddy officer" who remained with him to ensure the integrity of the evidence as well as chain of custody. I confirmed 2020-CA-01011 could relocate to the police department in accordance with department policy General Order 60.

Investigator A. Bailey responded to the police department and was responsible for the round count procedures and collection of evidence from involved 2020-CA-01011. Investigator Bailey documented her investigative actions in a supplemental report. For continuity purposes an excerpt of her report was copied below:

2020-CA-01011 was escorted to the Criminal Investigations Bureau conference room. 2020-CA-01011 was accompanied by his attorney, Stephen Webster, and another Officer, Joshua Armstrong. Also present during the collection of evidence from 2020-CA-01011 were the following personnel:

2020-CA-01011 had his handgun holstered with a magazine seated in the weapon and two magazines secured in pouches on the left side of his duty belt. Officer French counted the rounds of ammunition in Officer [redacted] handgun and magazines. 2020-CA-01011 was carrying a Glock 22 .40-caliber semi-automatic handgun (serial number PZE650), which contained one unfired cartridge in the chamber. There was a 15- round capacity magazine seated in the magazine well of the handgun, which contained eight unfired cartridges. In the magazine pouch closest to Officer [redacted] belt buckle was a 15-round capacity magazine which contained 15 unfired cartridges. In the magazine pouch farthest from Officer [redacted] belt buckle was a 15-round capacity magazine which contained 15 unfired cartridges. 2020-CA-01011 was not in possession of any other firearms or ammunition. It is standard for Officers to carry each of their three issued handgun magazines loaded to capacity (15) with one (1) cartridge chambered in their handguns, totaling 46 rounds (15+15+15+1). 2020-CA-01011 had was carrying 39 cartridges at the time of inspection, indicating 2020-CA-01011 likely fired seven (7) cartridges during the shooting the incident.

The collection of evidence occurred from approximately 3:15a.m. until 3:34a.m. on May 19, 2020. Officer French issued 2020-CA-01011 a temporary replacement handgun upon conclusion. Forensic Scientist (F.S.) Vernon Henderson took digital photographs of the handgun, cartridges, and magazines as they were counted. F.S. Henderson impounded the handgun, cartridges, and magazines as evidence. F.S. Henderson took digital photographs of 2020-CA-01011, who was wearing a standard police uniform. 2020-CA-01011 advised he did not have any physical contact with Woodard, therefore there was no expectation Woodard's DNA would be present on or about 2020-CA-01011. No buccal sample was collected from 2020-CA-01011 because there was no expectation that Officer [redacted] DNA would be present on or about Woodard.

Officer [redacted] body worn camera was obtained and Investigator Bailey initiated an upload of the video from the incident. However, 2020-CA-01011 was escorted to the Watch Commander's Office to have a download conducted for his Taser activity. Sergeant Ginny Osborn stood by with the body camera until the upload was completed. Sergeant Osborn verified the video properly uploaded before she returned Officer [redacted] body worn camera

to him.

While in the Watch Commander's Office, Sergeant Chris Papy conducted a download of Officer Taser activity. The activity indicated Officer Taser was not used during his encounter with Woodard. 2020-CA-01011, Stephen Webster, Sergeant Papy, and Investigator Bailey were present during the download of the Taser activity.

Tallahassee Police Department General Order 63 (Officer-Involved Action Resulting in Serious Injury or Death) mandates "Each involved officer shall initially be placed on administrative leave for a minimum of 72 hours, followed by an administrative assignment as directed by the Chief of Police or designee." In accordance with this policy, Chief Lawrence Revell met with 2020-CA-01011 and provided him notification he was being placed on administrative leave. 2020-CA-01011 was driven home by Officer Armstrong.

Officer Elijah DeGraw's Interview

Investigator Bailey conducted the interview with Officer DeGraw. Investigator Baily summarized the interview within her supplemental report. For continuity purposes, I've copied the below excerpt from Investigator Bailey's report:

On May 19, 2020 at approximately 4:00a.m., Officer DeGraw was interviewed in the Criminal Investigations Bureau Interview Room 1 regarding the shooting incident. The interview was audio and video recorded. Officer DeGraw was advised of oath and perjury via written warning, which he indicated verbally and via signature he understood. Officer DeGraw swore or affirmed the statement he would provide would be wholly true.

Officer DeGraw advised the following:

Officer DeGraw works the midnight shift (21:15-07:15) in the Northwest District of the City of Tallahassee. Officer DeGraw was finishing a call for service at a hotel on North Monroe Street when he observed the call for service at Circle K regarding Haines' injuries. Officer DeGraw requested Dispatch send him the call at Circle K and he arrived on scene shortly thereafter. Another Officer was en route to be Officer DeGraw's back-up, but 2020-CA-01011 cancelled the other unit and responded to assist Officer DeGraw. Haines was bleeding from the areas of his eyes, elbows, and knees, as though he'd been in a fight on the ground. Haines reported he had only recently met Woodard and thought his first name was possibly

“Michael.” Haines advised he was drinking and eating pizza with Woodard and several other transients across the street at the China Super Buffet. Haines recalled Woodard was carrying two knives and began threatening people with the knives. Haines told Woodard to stop threatening people with the knives. Woodard pulled out a knife and threatened to cut and kill Haines with the knife, at which time Haines and Woodard began physically fighting.

Woodard did not use the knife to harm Haines, but Haines recalled Woodard using his hands to attempt to gouge out Haines’ eyeballs. Haines said he was able to get away and come across the street to Circle K. Haines advised his cell phone possibly fell out during the fight at the China Super Buffet. Haines advised Woodard was possibly still at the incident location, as well. Haines described Woodard as a white male with a short, crew-style haircut wearing a shirt, long pants, and being in the company of a small, black dog, which was possibly a chihuahua. While Officer DeGraw was obtaining Haines’ statement, 2020-CA-01011 arrived at Circle K and witnessed a portion of the interview. Officer DeGraw asked 2020-CA-01011 if he () could go across the street to the China Super Buffet to check for Haines’ phone. 2020-CA-01011 was provided a description of Woodard. 2020-CA-01011 drove across the street to the China Super Buffet and Leon County Emergency Medical Services assisted Haines to the ambulance. As Haines was being evaluated, Officer DeGraw observed 2020-CA-01011 standing near the drive-through awning of the China Super Buffet, illuminating Woodard near bushes at the northeast corner of the building with his flashlight. Officer DeGraw told LCEMS personnel he had to go across the street and Officer DeGraw began running toward the China Super Buffet. While crossing the street, Officer DeGraw heard 2020-CA-01011 yelling, “Drop the knife! Drop the knife! Drop the knife!” as Woodard advanced toward 2020-CA-01011, who was running from the area of the drive-through awning toward North Monroe Street. Officer DeGraw heard approximately 5-7 gunshots fired.

Woodard continued to advance toward 2020-CA-01011, despite being shot, or at least shot at. Officer DeGraw notified Dispatch that shots had been fired. By the time Officer DeGraw reached the eastern parking lot of the China Super Buffet, 2020-CA-01011 was holding Woodard at gunpoint and the black dog was still on scene. Woodard was in a prone position with his head toward North Monroe Street (east) and his feet toward the China Super Buffet building (west). Woodard’s left hand was under his torso and his right hand was extended outward, above his head with a large fixed-blade knife, inches away from his right hand. There was at least one knife sheath on Woodard’s hip, but there may have been two. Woodard had an apparent gunshot wound to his forehead. Woodard’s injuries and condition

were inconsistent with life (motionless and not making any noise). Although Officer DeGraw believed Woodard was deceased, he requested Dispatch send LCEMS to the scene for Woodard’s injuries. Officer DeGraw put gloves on his hands and handcuffed Woodard while 2020-CA-01011 continued to provide deadly cover. LCEMS came from across the street and several Officers arrived on scene to assist, including Sergeant Kathy Connell. Sergeant Connell informed LCEMS Woodard was deceased and requested they not manipulate the scene. Sergeant Connell assigned Officer Joshua Armstrong to accompany 2020-CA-01011, and she assigned Officer Gary Senters to accompany Officer DeGraw. Officer DeGraw was not questioned about the incident by anyone prior to the interview.

Officer DeGraw’s body worn camera was uploaded and a verification was conducted to confirm the video was properly uploaded. Officer DeGraw’s verbal account of the incident was consistent with the footage captured via his body worn camera. During the interview, Officer DeGraw’s recounted Haines provided a potential name for Woodard, which was possibly “Michael.” Officer DeGraw stated he wasn’t confident “Michael” was the name Haines provided for Woodard. DeGraw’s body camera video captured Haines providing the name “William” as a possible first name for Wilbon Woodard.

Officer 2020CA1011 Interview

On May 21st, 2020, 2020-CA-01011 came to the Tallahassee Police Department to participate in a scheduled interview. 2020-CA-01011 was accompanied by his attorney S. Webster. In accordance with Tallahassee Police Department policy, General Order 63, 2020-CA-01011 was permitted to review his body worn camera footage of the incidents before his formal interview. 2020-CA-01011 was provided access by Investigator A. Bailey to the footage. A digital log was maintained by the application which housed the video footage (Axon). It was reviewed before and after 2020-CA-01011 reviewed his videos. It confirmed 2020-CA-01011 only reviewed his videos as permitted by policy. 2020-CA-01011 was provided access to his two videos reference this matter. The first was footage captured when he arrived at the Circle K. The second was footage which captured his actions at the China Super Buffet. 2020-CA-01011 was afforded privacy with his attorney to review the footage. The review occurred in the Criminal Investigations Conference Room. Investigator Bailey and I remained outside the conference room as the review occurred.

After 2020-CA-01011 completed his review of body worn camera footage, he and his attorney went to Criminal Investigations Bureau Interview room 1. The interview was recorded with the department’s

in-room camera system as well as with a body worn camera for redundancy purposes. I summarized the details of the interview below. The summary is not a transcription. The video recorded interview should be referenced as the best evidence of the interview. Because 2020-CA-01011 did not know the name of the victim (Haines) or the suspect (Woodard) they are referred to as "victim" and "suspect" in the interview summary.

The interview began at 3:31 PM. Investigator Bailey and I conducted the interview. At the onset I told 2020-CA-01011 I appreciated his willingness to be interviewed. I reiterated the purpose of the interview was for this criminal investigation. I differentiated the criminal investigation from the administrative investigation that would be conducted by the department's Internal Affairs Unit. I advised 2020-CA-01011 his Miranda Rights. I read the rights from a department issued form. 2020-CA-01011 acknowledged his rights and signed the departmental form. 2020-CA-01011 while represented by legal counsel agreed to provide a statement/be interviewed.

2020-CA-01011 confirmed he responded to the call for service at the Circle K (which was the precursor to the shooting). 2020-CA-01011 knew Officer DeGraw was dispatched to a call for service at the Circle K. He learned from his radio the victim was "bloody." 2020-CA-01011 heard Sergeant Connell ask Officer DeGraw if he had backup (via radio). Officer Senters, who was next to 2020-CA-01011, volunteered to respond as a backup officer for Officer DeGraw. 2020-CA-01011 cancelled Officer Senters and responded instead. 2020-CA-01011 said he responded instead because he was assigned to the "zone" where the call for service originated (patrol officers are assigned to geographic locations within the City of Tallahassee. Those locations were referred to as "zones" and are currently referred to as "Beats").

2020-CA-01011 said he responded to the Circle K and parked next to one of the gas pumps. He approached Officer DeGraw who spoke with the victim. 2020-CA-01011 heard the victim tell Officer DeGraw the suspect "had a knife." He heard the victim was "beat up" and 2020-CA-01011 said he observed blood on the victim. 2020-CA-01011 did not recall the name of the victim but was able to describe him. 2020-CA-01011 knew the victim believed the suspect remained in the area of the China Super Buffet and had a dog. Thereafter, EMS arrived, and the victim explained he needed to recover his phone. 2020-CA-01011 heard the victim describe the suspect and wrote the description down. Officer DeGraw requested 2020-CA-01011 to go to the China Super Buffet to search for the victim's phone. He explained the victim was reluctant to go to the hospital without his phone.

I asked 2020-CA-01011 if he recalled any injuries to the victim. 2020-CA-01011 said the victim had "blood all over him" and the victim said the suspect gouged his eyes. Specifically, 2020-CA-01011 recalled

blood on the victim's face, hands, and arms. 2020-CA-01011 knew the suspect was armed with knives.

2020-CA-01011 drove his patrol vehicle to the China Super Buffet. He parked beneath the awning. I showed 2020-CA-01011 a printed daylight image of the China Super Buffet. 2020-CA-01011 identified the northern entrance as the driveway he pulled into the business. He notated where he parked. 2020-CA-01011 exited his vehicle and used a flashlight to illuminate the area. 2020-CA-01011 said he observed belongings. I asked 2020-CA-01011 about the lighting conditions of the area. He mentioned streetlights being on Monroe Street but was unsure if there was any lighting at the business.

2020-CA-01011 said he searched for the victim's cellphone and traveled from the awning northwards (illustrated on the image). As he walked north 2020-CA-01011 said he observed the suspect at the northeast corner. 2020-CA-01011 said the suspect attempted to hide behind the bushes. 2020-CA-01011 used his flashlight to illuminate the suspect. 2020-CA-01011 asked the suspect "what are you doing behind the bushes." 2020-CA-01011 told me he had probable cause to detain the suspect in the previous attack and knew the suspect's description.

2020-CA-01011 said he heard a dog from the area (northeast corner) which garnered his attention. The sound of the dog indicated to 2020-CA-01011 the suspect was in the area. 2020-CA-01011 indicated in the printed image where he first observed the suspect. 2020-CA-01011 said he was only able to see the suspect's head and left shoulder beyond the bushes. 2020-CA-01011 reiterated he used his flashlight to illuminate the suspect and told him to come out of the bushes.

2020-CA-01011 walked east across the parking lot, so he had a better view of the partially concealed suspect. The suspect stood up and faced 2020-CA-01011 said the suspect "just stared" at him. At this point 2020-CA-01011 was able to see the entire suspect except for the suspect's right hand which remained concealed in the bushes. 2020-CA-01011 specifically told the suspect to take his hand out of the bushes. The command was repeated, and 2020-CA-01011 said he gave the commands for his safety. 2020-CA-01011 explained he did not recall knowing the suspect to be armed with a knife when he made contact with the suspect, but his memory was refreshed of this fact when he watched his body worn camera footage. 2020-CA-01011 said he was concerned in general for his safety because the suspect refused to make his hand visible.

Because of the suspect's actions, 2020-CA-01011 removed one of the safety features on his duty holster and placed his hand onto his department issued handgun. When this happened 2020-CA-01011 described the suspect as taking a momentary step/lunge towards him. After this occurred the suspect remained in the same area and his hand remained concealed in the same bush.

2020-CA-01011 said he could not recall at what precise point he retrieved his duty pistol from his holster. The suspect moved his hand from behind the bush and "started coming at me." I asked 2020-CA-01011 if he observed anything in the suspect's hand. 2020-CA-01011 said the suspect had a knife in his hand. At this point the suspect's arms were by his side (demonstrated by 2020-CA-01011). When this occurred 2020-CA-01011 estimated there was less than fifteen feet between himself and the suspect.

2020-CA-01011 said he repeatedly ordered the suspect to "drop the knife." The suspect "came at me" and 2020-CA-01011 said he "pulled the trigger twice." Despite shooting twice at the suspect, he continued to "come at me." 2020-CA-01011 described having to step backwards ("backpedaling"). Specifically, 2020-CA-01011 said he walked backwards toward Monroe Street (west). 2020-CA-01011 told me he was "in fear he (suspect) was gonna hurt me." 2020-CA-01011 recalled the injuries he observed on the initial victim as a factor in being afraid of injury from the suspect.

2020-CA-01011 clarified his course of fire:

2020-CA-01011 said he fired twice at the armed suspect, described a pause where he ordered the suspect to "drop the knife" and radioed "shots fired". 2020-CA-01011 fired a second string of fire (2 shots), looked behind him to make sure he did not walk onto Monroe Street, knew the suspect "was still coming at me" and said "I'm gonna kill you." 2020-CA-01011 then fired twice more, paused, and made an additional shot.

After 2020-CA-01011 described his third string of fire, he said the suspect fell to the ground. 2020-CA-01011 said he immediately recognized the knife on the ground next to the suspect's hands. At some point during the shooting, 2020-CA-01011 said he made a second radio transmission that "shots" were fired. He heard Officer DeGraw call his ID number () on the radio but did not recall the transmission. After the suspect fell, Officer DeGraw arrived and placed the suspect into handcuffs. 2020-CA-01011 said Officer DeGraw paused to put on a pair of gloves before handcuffing the suspect. 2020-CA-01011 described how he and Officer DeGraw positioned themselves on the same side of the suspect as to not create a "crossfire" situation. This statement insinuated 2020-CA-01011 continued to use his department handgun to maintain deadly cover on the suspect. 2020-CA-01011 said the suspect maintained possession of the knife in his right hand "the entire time" (during Officer three separate strings of fire) until the suspect fell to the ground (after the final string of fire). After the suspect fell, 2020-CA-01011 said he observed the knife on the ground near the suspect's right hand.

(after the final string of fire). Officer DeGraw secured the suspect into handcuffs. After the suspect was secured in handcuffs, 2020-CA-01011 holstered his handgun. He then heard sirens and Sergeant Connell (patrol supervisor) arrived. Sergeant Connell asked 2020-CA-01011 what responding officers needed to search for. 2020-CA-01011 relayed the entire incident was in the immediate area.

I asked 2020-CA-01011 questions to clarify information in his account. 2020-CA-01011 told me when he initially observed the suspect, he knew the suspect matched the description provided by the initial victim who was attacked. 2020-CA-01011 estimated from the time the suspect moved towards him with the knife to the time the he fired his last shot was ten seconds. 2020-CA-01011 said he did not believe he allowed the suspect to get closer than ten feet of him. After Sergeant Connell arrived, 2020-CA-01011 said Officer Armstrong was assigned as his "buddy officer." 2020-CA-01011 said he remained with Officer Armstrong until his legal counsel arrived. Thereafter, he relocated to the police station.

After 2020-CA-01011 completed his chronological account of the incident, he was asked additional clarifying questions and questions about his perceptions about the events he previously described. 2020-CA-01011 said he believed the China Super Buffet to be closed and without patrons at the time he went to search for the victim's phone. 2020-CA-01011 said it would be unusual for anyone to be at the closed business at the time he responded. When 2020-CA-01011 first observed the suspect, he said the suspect was "concealed behind the bushes." 2020-CA-01011 explained the area where the suspect concealed himself was not a "normal walkway" and it would be usual for any person to be in that area.

2020-CA-01011 said when he initially observed the suspect, he was only able to see the suspect's forehead and left shoulder. This led 2020-CA-01011 to believe the suspect knelt or crouched behind the bushes. When more of the suspect became visible, 2020-CA-01011 believed the suspect stood up. 2020-CA-01011 believed the suspect stood up as a response to Officer attempt to make verbal contact. After the suspect stood and became more visible, 2020-CA-01011 confirmed the suspect continued to conceal his right hand. 2020-CA-01011 was asked based on his training what concerns he had based on the suspect's efforts to keep his right hand concealed. 2020-CA-01011 believed the suspect concealed "a gun, a knife, a wrench, or anything that could be used to hurt me."

2020-CA-01011 contrasted the actions of the suspect with other suspects he's had contact with, in the course of serving as a law enforcing officer. 2020-CA-01011 demonstrated how when suspects are ordered to "show me your hands" they comply. It was reiterated by 2020-CA-01011 the suspect's refusal to comply with his command caused him to think "what are you hiding." 2020-

explained based on the suspect's initial actions (concealing his right hand) he was concerned enough to remove one of his duty holster's safety features and grasp his handgun.

2020-CA-01011 said the suspect "had this stare about him." 2020-CA-01011 said he'd "never seen it before." 2020-CA-01011 interpreted the suspect's stare to mean "someone's gonna leave here. It's gonna be either me or you." Based on the stare, 2020-CA-01011 felt as if the suspect would hurt him and mentally prepared to defend himself. 2020-CA-01011 reiterated, "everything happened so fast."

2020-CA-01011 was asked if when the suspect emerged from behind the bush if it appeared like he was going to surrender. 2020-CA-01011 said the suspect did not act like he was going to surrender and instead "came at me" while armed with the knife. 2020-CA-01011 was asked if he did not back away from the suspect what he believed would have occurred. He explained he believed the suspect would have stabbed him. 2020-CA-01011 was asked if he did not shoot the suspect what he believed would have happened to him. 2020-CA-01011 responded, "I would have been in the hospital."

2020-CA-01011 was asked if he's witnessed victims who have been injured with a knife. He responded affirmatively. 2020-CA-01011 knew knife inflicted injuries could cause serious injury or death. 2020-CA-01011 was asked if he recalled what the knife looked like. He said he thought it had a black handle and described it as a "hunting style knife" with a fix blade. 2020-CA-01011 demonstrated with his hands the size of the knife.

"he (suspect) had hit the ground and stopped moving. The threat had ended."

2020-CA-01011 was asked why he stopped shooting. He responded:

After the suspect fell, he said he did not recall the suspect breathing. 2020-CA-01011 recalled how he observed a gunshot wound to the suspect's head. 2020-CA-01011 was asked about his training and being knowledgeable in any medical aid for a gunshot wound to the head. 2020-CA-01011 said he was unaware of any aid he could have provided to the gunshot wound to the suspect's head. 2020-CA-01011 recalled EMS responded to the location from across the street. 2020-CA-01011 said EMS did not provide aid to the suspect and realized he was beyond medical aid.

At the conclusion of the interview, 2020-CA-01011 signed the printed image he used in the interview to refer to and notate locations. This image was retained as evidence. I explained to 2020-CA-01011 the grand jury process. I provided 2020-CA-01011 with an opportunity to provide me with any other information he wanted included in his formal interview. 2020-CA-01011 reiterated the suspect "made the choice" and "he made it for me." 2020-CA-01011 added before he watched the body worn camera

footage his heart rate was in the 70's and when he reviewed the footage it rose to the 120's. 2020-CA-01011 and his counsel were invited to contact us if they recalled any information in the future then wanted to add.

Suspect Wilbon Woodard's Autopsy

Woodard's autopsy was performed on May 19th, 2020 at approximately 10:45 AM. The autopsy occurred at the Office of the District Two Medical Examiner's Office. This was the location where Woodard's remains were transferred to after he was removed from the parking lot of the China Super Buffet. The autopsy was performed by Doctor Flannagan. Before the autopsy was performed, a photograph of the evidence bag which contained Woodard's remains was photographed (20M291001). The evidence seal remained intact. This demonstrated the integrity of Woodard's remains as evidence in this investigation.

Forensic Technician J. Sitero and I attended the autopsy. The Medical Examiner's case number for Woodard was: 20M-291. I removed the handcuffs placed on Woodard during the autopsy procedure. Woodard was found to have a \$50 bill inside his boot (20M291026). Woodard was found to have a Harley Davidson wallet concealed inside the front of his waistband (20M291027). The wallet was determined to contain \$10,930 in US currency. Woodard was found to have and additional \$432.24 in US currency within his clothing.

Doctor Flannagan determined Woodard was struck by projectiles (gunshots) at the below described locations:

- Entrance wound on the lower portion of his upper chest (20M291068)
 - o Projectile/bullet was observed in X-Ray in lower right of back and removed (20M291160, 20M291161, and 20M291088)
- Entrance wound on front of upper left bicep (20M291069)
 - o Projectile/bullet was observed in X-Ray in left triceps and removed (20M291174, 20M291175, 20M291176, and 20M291177)
- Two Entrance wounds which continued and passed through front of upper right forearm (20M291091, 20M291120, and 20M291090)
- Entrance wound on top of left of neck (20M291096)

- Projectile/bullet was observed in X-Ray in lower left back of head and removed (20M291164, 20M291165, and 20M291085)

In addition to the gunshot injuries, Woodard was observed to have suspected blood on and round his left fingertips/fingernails (20M291102). Woodward was observed to have suspected blood on and around his right thumb/thumbnail (20M291125). This was consistent with Haines' account of Woodard using his thumbs to gouge his eyes.

At the conclusion of the autopsy, all evidence and property were transferred from Doctor Flannagan to Forensic Technician J. Sitero. Due to the amount of funds discovered on Woodard, Lieutenant J. Baldwin responded to the Medical Examiner's Officer in accordance with department policy to verify the amount of money discovered on Woodard. Lieutenant J. Baldwin signed a department property receipt verifying the amount of recovered funds.

On June 26th, 2020, I received the autopsy report for Woodard. The report was authored by Doctor Flannagan. The Medical Examiner's case number was 20M-291. I copied the Final Pathologic Diagnoses below:

- I. Penetrating gunshot wound of lower chest/abdomen.
 - A. Extensive tears of the left lobe of the liver.
 - B. Hemoperitoneum (150 ml).
 - C. Projectile recovered from right lower back.
- II. Penetrating gunshot wound of head.
 - A. Entry wound of right top of head.
 - B. Injuries of right and left cerebral hemispheres and left lobe of cerebellum.
 - C. Fractures of the calvarium and basilar skull.
 - D. Projectile recovered from soft tissues of lateral left upper neck.
- III. Penetrating gunshot wound of left upper arm.
 - A. Soft tissue injuries of upper arm.

- B. Projectile recovered from skeletal muscle of upper arm.
- IV. Perforating gunshot wound of proximal right forearm.
 - A. Soft tissue injuries of right forearm.
 - B. No projectile fragments recovered.
- V. Graze gunshot wound of anteromedial right forearm.
- VI. Minor contusions and abrasion of the forehead, left hip and left arm.
- VII. Postmortem blood positive for ethanol (0.122 g/dL).

The case of death was listed as: "Multiple gunshot wounds." The Manner of death was listed as "Homicide (shot be police officer during confrontation)."

Next of Kin Notification and Suspect Background Information from Family

On May 19th, 2020, Victim Advocate S. Latorre and I traveled to 711 Little John Road to contact Laura Woodard. Laura Woodard was determined to be the closet local relative (next of kin) to Wilbon Woodard. VA. Latorre and I spoke with Laura Woodard on the front porch of her residence. The conversation was not recorded at it was a next of kin notification.

Laura Woodard explained to us she was Wilbon Woodard's sister-in-law. Laura Woodard was married to Wilbon Woodard's late brother (deceased). Laura Woodard told us Wilbon Woodard was at her residence on May 18th, 2020. Laura Woodard provided us with background information about Wilbon Woodard. We learned Wilbon Woodard's wife passed and he received a sum of money as a result. Wilbon Woodard was known to conceal a large sum of cash on his person.

Laura Woodard told us Wilbon Woodard was evicted from his residence and stayed with his son Shane Woodard. Laura Woodard said Wilbon Woodard's mental state became increasingly impaired. Laura Woodard said during the previous week while he resided with his son, Wilbon Woodard used a hatchet and tried to fight ghosts. This was the reason Wilbon Woodard was no longer permitted to reside with his son. Wilbon Woodard asked Laura Woodard if he could reside with her and she declined. Wilbon Woodard's son rented him a hotel room at the Motel 6 located on North Monroe Street (2738 North Monroe Street). We informed Laura Woodard of Wilbon Woodard's death. VA Latorre provided Laura Woodard with support services. Laura Woodard

inquired about Wilbon Woodard's money so it could be used to offset funeral costs.

On May 20th, 2020, VA Latorre spoke with Laura Woodard. She informed Shane Woodard of Wilbon Woodard's death. Laura Woodard reiterated some of the information she shared with VA Latorre on May 19th, 2020 when we notified her of Wilbon Woodard's death. In addition, Laura Woodard detailed examples of Wilbon Woodard's declining mental health. This included Wilbon Woodard talking with his deceased brother and overall confusion. Wilbon Woodard told Laura Woodard he refused medical treatment for existing conditions and wanted to die.

On May 28th, 2020 I sent a release for the sum of money discovered on Wilbon Woodard's person. The sum was \$16,612.24. It was released to Wilbon Woodard's daughter Angela Page. Before I authorized the release, I received approval from the department's legal advisor Flury.

It should be noted the Motel 6 at which Wilbon Woodard stayed was approximately .5 miles from the China Super Buffet (2698 North Monroe Street).

Requests for Evidence to be Processed and Examined

On June 1st, 2020, I completed two requests to have evidence recovered during this investigation examined by the Florida Department of Law Enforcement lab. The first request encompassed biological evidence while the second request encompassed ballistic evidence. The requests were made in accordance with the Florida Department of Law Enforcement's Evidence submission guidelines.

I requested to have the below evidence submitted for biological examination:

- Item 22: Knife with suspected blood recovered next to Woodard
- Item 18: Swab of Woodard's left hand
- Item 17: Swab of Woodard's right hand
- Item 14: Woodard's buccal (DNA standard)
- Item 13: Leaf with suspect blood

I requested to have the below evidence submitted for ballistic examination:

- Item 38: Projectile from Woodard's left arm

On June 30th, 2020, I received a Laboratory Report authored by the Florida Department of Law Enforcement. The associated FDLE Number was 20200101224. The report was authored by Crime Laboratory Analyst Maria Hiott. I reviewed the report. The report included forensic determinations for the biological evidence submitted in this investigation.

The leaf with suspected blood (Item 13) was confirmed to be blood. The blood was determined not to belong to Woodard. It is the investigative belief the blood belonged to victim Haines and evidence of the precipitating Aggravative Battery which necessitated the call for service prior to the officer involved shooting. The swabs of Woodard's hands contained a DNA mixture which included Woodard (expected donor). According to the report, "due to the limited nature of these results, this data is not interpretable." In reference to the knife discovered adjacent to Woodard's remains, the examiner tested the knife to "determine the handler of this item." The resulting DNA profile discovered on the knife matched Woodard:

"The observed DNA profiles are greater than 700 billion times more likely to occur if them samples originated from Wilbon Woodard than from an unrelated individual."

To summarize, the Florida Department of Law Enforcement's Biology section was able to confirm the Woodard's DNA was discovered on the knife recovered adjacent to his remains. This furthered Woodard was armed with the recovered knife when he attacked 2020-CA-01011.

Applicable Law

Florida State Statute 776.012 governs Justifiable Use of Force. Officer actions are governed by this statute. The statute is copied below:

(1) A person is justified in using or threatening to use force, except deadly force, against another when and to the extent that the person reasonably believes that such conduct is necessary to defend himself or herself or another against the other's imminent use of unlawful force. A person who uses or threatens to use force in accordance with this subsection does not have a duty to retreat before using or threatening to use such force.

(2) A person is justified in using or threatening to use deadly force if he or she reasonably believes that using or threatening to use such force is necessary to prevent imminent death or great bodily harm to himself or herself or another or to prevent the imminent commission of a forcible felony. A person who uses or threatens to use deadly force in accordance with this subsection does not have a duty to retreat and has the right to stand his or her ground if the person using or threatening to use the deadly force is not engaged in a criminal activity and is in a place where he or she has a right to be.

Investigative Summary and Findings

On May 19th, 2020 at 1:29 AM Tallahassee Police Officer E. DeGraw responded to a call for service at the Circle K located at 2683 North Monroe Street. Because of the violent nature of the call, patrol supervisor Sergeant Connell inquired if Officer DeGraw required a backup officer. At 1:32 AM, Officer radioed he would respond to the call for service to back up Officer DeGraw. 2020-CA-01011 arrived at the Circle K at 1:33 AM.

2020-CA-01011 visually observed victim Haines who provided a verbal account of the incident to Officer DeGraw. 2020-CA-01011 witnessed visible injuries to victim Haines. 2020-CA-01011 would describe victim Haines as having "blood all over him" during his interview. Body worn camera footage captured victim Haines' injuries as observed by 2020-CA-01011; it corroborated Officer description. Security video at the Circle K also recorded victim Haines contact with Officers. 2020-CA-01011 heard victim Haines describe the attack. 2020-CA-01011 was present when the Haines told Officer DeGraw the outstanding suspect was armed with a knife. Moreover, 2020-CA-01011 was present when the victim told Officer DeGraw the suspect threatened him with the knife and said, "I'll cut you, I'll Kill you."

Haines provided a description of the suspect which was heard by 2020-CA-01011 who wrote it down. Haines said he required his cellular phone before he would go to the hospital with Leon County Emergency Medical Services for treatment for his injuries. Haines told officers his phone was at the Super China Buffet. Haines said this is where he was attacked by the suspect as well as the suspect's last known location. Officer DeGraw asked 2020-CA-01011 if he would attempt to locate Haines cellphone. 2020-CA-01011 agreed, and departed the Circle K.

2020-CA-01011 drove to the Super China Buffet and parked his marked police vehicle beneath the awning which covered the main entrance to the business. The business was closed. Based on body worn camera footage there was no exterior lighting outside the business. Because of the time, there was minimal natural light. 2020-CA-01011 exited his vehicle and due to the limited lighting used a flashlight to illuminate the area. 2020-CA-01011 began to search the area for victim Haines' cellular phone.

Approximately 30 seconds after he exited his vehicle 2020-CA-01011 heard a dog bark. 2020-CA-01011 said in his interview the sound of the dog bark alerted him as he knew the suspect had a dog. At this point 2020-CA-01011 activated his body worn camera and the audio was activated. 2020-CA-01011 said his attention was drawn to the shrubs located at the northeast side of the business. 2020-CA-01011 said he observed a male partially concealed by the bushes. 2020-CA-01011 used his flashlight to illuminate the male. The male said "what" to 2020-CA-01011 asked the suspect why he was hiding and "staring at me."

During Officer interview he said the concealed male matched the description of the suspect who injured the victim. 2020-CA-01011 repositioned himself at an angle and used his flashlight, so he was better able to observe the suspect. The suspect no longer crouched but stood. 2020-CA-01011 said the suspect was visible except for his right hand. 2020-CA-01011 said the suspect purposefully kept his right hand concealed in the bushes. During his interview 2020-CA-01011 said the suspect's efforts to conceal his right hand caused him concern and he believed the suspect concealed a weapon.

2020-CA-01011 repeatedly ordered the suspect to come out from behind the bushes. 2020-CA-01011 told the suspect to "get your hand out of the bush." The suspect then charged at 2020-CA-01011 while armed with the knife.

2020-CA-01011 told investigators he observed a knife in the suspect's hand as he moved towards him. 2020-CA-01011 stepped rearwards and ordered the suspect twice to drop the knife. 2020-CA-01011 said

if he did not shoot the suspect he would have been injured or killed. 2020-CA-01011 fired two rounds from his department issued handgun at the suspect. 2020-CA-01011 provided the suspect with additional commands to drop the knife after he fired his first two shots. The suspect refused and continued towards 2020-CA-01011 while armed with the knife. 2020-CA-01011 fired twice more. The suspect continued and told 2020-CA-01011 he would "kill ya." Based on the body worn camera footage, it appeared the suspect became closer to 2020-CA-01011 despite Officer efforts to step backwards and previous courses of fire. 2020-CA-01011 fired three more rounds which stopped the suspect's attack. The suspect fell to the ground.

Based on the body worn camera footage, 2020-CA-01011 fired all seven rounds in 6 seconds. During Officer course of fire, he radioed "shots fired." Officer DeGraw who was at the Circle K responded to assist 2020-CA-01011. The knife the suspect was armed with was captured in body worn camera footage on the ground next to the suspect's right arm. The footage was continuous, and the knife was not disturbed. 2020-CA-01011 used his handgun to cover the suspect and Officer DeGraw secured him into handcuffs.

2020-CA-01011 said he observed a gunshot wound to the suspect's head. 2020-CA-01011 said the suspect did not display any signs of life. Paramedic J. Perez responded and observed the suspect to be deceased. Paramedic Perez said during his interview he observed the knife next to the deceased suspect. Based on the initial investigation, it was determined the suspect who assaulted 2020-CA-01011 was the same suspect who attacked victim Haines. The suspect was determined to be Woodard. It would be learned from Woodard's family his mental health was diminished. Woodard's family said in the days prior to his death he spoke to deceased family members and even used an edged weapon to attack "ghosts". Woodard's family was concerned based on his actions they rented him a hotel room (near the China Super Buffet) in lieu of allowing him to reside with them.

This investigation yielded the below determinations for May 19th, 2020:

- 2020-CA-01011 was employed by the Tallahassee Police Department as a sworn law enforcement officer pursuant to FSS: 943.10(1)
- 2020-CA-01011 worked his scheduled shift as a uniformed patrol officer operating a marked police vehicle (Police insignia and emergency lights)
- 2020-CA-01011 was qualified with his department issued handgun (Glock 22 .40 caliber handgun^{2020-CA-1011})

- Relocated and was better able to observe the suspect
- Became fearful the suspect was armed with a weapon because the suspect maintained concealment for his right hand
- Became increasingly fearful after the suspect refused to show his right hand
- Was assaulted by the suspect who was armed with a knife
- Ordered the armed suspect repeatedly to “drop the knife.”
- Was afraid if he did not shoot the suspect he would be injured or killed
- Used his department issued handgun to shoot twice at the suspect
- Gave the suspect the command to drop the knife
- Used his department issued handgun to fire twice more at the armed suspect
- The armed suspect continued towards 2020-CA-01011 and told him “I’ll kill yea”
- 2020-CA-01011 used his department issued handgun to fire three more times at the suspect
- The suspect fell to the ground
- Officer DeGraw arrived and placed the suspect into handcuffs
- The knife the suspect was armed with was on the ground next to the suspect’s right arm
- The Florida Department of Law Enforcement confirmed the suspect’s DNA was discovered on the recovered knife which indicated he was the handler of the item
- EMS responded and it was determined the suspect was deceased/beyond medical treatment with a gunshot wound to his head

Based on the investigation, probable cause was established to support the suspect who assaulted 2020-CA-01011 with a knife was the same suspect who committed an Aggravated Assault with a Deadly Weapon and Aggravated Battery. Background information was provided to support the suspect suffered a deteriorated mental state and used an edge weapon to attack “ghosts.” This

investigation established probable cause to support Wilbon Woodard was the suspect who committed an Aggravated Assault with a Deadly Weapon against 2020-CA-01011 as captured on body worn camera footage. 2020-CA-01011 was the victim of the offense.

Officer actions on May 19th, 2020 are governed by Florida Statute 776.012. Pursuant to Florida Statute 776.012 (previously cited within this report) 2020-CA-01011 would be justified in using deadly force if the force he used was "necessary to prevent imminent death or great bodily harm to himself." Based on this investigation, 2020-CA-01011 was assaulted by a suspect armed with a straight edged knife in low light conditions. 2020-CA-01011 told investigators if he did not shoot the armed suspect, he believed he could be killed. Evidence collected in this investigation affirms the suspect was armed with a knife and the suspect assaulted 2020-CA-01011 with the knife while making the claim, "I'll kill yeah." Based on this investigation, the standards set forth in Florida Statute 776.012 are satisfied and Officer use of force is justified under Florida law.

The findings of this investigation will be reviewed the State Attorney's Office for the Second Judicial Circuit of Florida. Those results will be documented in a subsequent report.

The suspect (Wilbon Woodward) approached Off. with a knife. After not complying to officer comands, Off. discharged his firearm and struck the suspect. The suspect was pronounced deceased on scene.

Overall, mid-range, and close-up photographs were taken prior to processing and evidence collection.

The scene was then mapped out by the use of the FARO 3D laser scanning unit. The unit was set up to scan the parking lot and the drive-up entrance area of the China Super Buffet. A total of (5) scans were completed.

The data was uploaded and registered at the TPD Forensic Science Unit via FARO Scene computer program.

At the entrance to the business off of the southbound lanes of North Monroe St, (4) cartridge casings were located on the pavement. Evidence Marker's #1-#4 were placed at each cartridge casing. To the southeast, another cartridge casing was located. Evidence marker #5 was placed at this cartridge casing. To the northwest of Evidence Marker #5 another cartridge casing was located adjacent to the decedent. Evidence Marker #6 was placed at this cartridge casing. To the south of Evidence Marker #6, another cartridge casing was located on the pavement. Evidence Marker #7 was placed at this cartridge casing. To the southeast of Evidence Marker #7, was the entrance and drive-up overhang area of the Super China Buffet. There were blankets, beer cans, and a pizza box on the ground around the front door to the business. On a brick pillar ledge, a knife was located. Adjacent to the brick pillar, was a leaf with suspected blood on it. Evidence Marker #8 was placed here.

On the north side of the business, a plastic phone cover was located with the number "274-3110" written on a piece of blue tape stuck to the outside of it. To the north of the cover, in the grass was a suitcase. The suitcase had clothing and various items located inside of it. As requested by Inv. Warren, the suitcase was collected.

The decedent was laying facing in a downward position predominately on his left side. The head of the decedent was facing to the northwest and his feet to the southeast. There was suspected blood present on the decedent's clothing and arms. A large pool of suspected blood was present on the decedent's head on the pavement around his head. decedent's body, attached to his belt were (2) empty knife holsters. Sticking out of the decedent's back right pocket was a black wallet. At approximately 5:30 ALG Funeral transport arrived. The body bag was sealed with a tag and evidence tape. The body tag and seal were photographed.

At 10:30 I arrived at the Leon County Medical Examiner's Office for the autopsy. The autopsy was performed by Dr. Flanagan. Inv. Warren was also present for the autopsy.
